In producing herewith 04 (Four) accused persons namely (1) Shikar Chandra Murmu (28 Yrs), S/O-Lt-Ghashiram Murmu of Vill-Usuldungri, 2) Mutuk Paharia (33 yrs), S/O-Lt-Bhikhu Paharia of Vill-Jhilling Sereng both PS-Baghmundi, Dist-Purulia 3) Paresh Mandi (24 Yrs), S/O-Sukdeb Mandi, (4) Tapan Majhi @ Hango (23 Yrs), S/O-Badal Majhi both of Vill- Nowagarh, PS-Jhalda, Dist-Purulia along with seized articles such as 1. One improvised country made iron made one shooter pipe gun having total length – 9.5 inch (Butt-3.5 Inch, Barrel-6 inch) loaded with one live ammunition, 2. One live ammunition having length 06 CM, 3. One Iron Bhojali having wooden butt length 14.5 inch, 4. One Yamaha (Saluto RX) Red and Black colour motor cycle having without registration number, 5. 01 (One) Iron Rod having length 3 ft 4 Inch, 6. One black colour steel made folding knife having length 8.5 inch, I SI Mukul Carmaker do hereby submit that today on (07.04.2021) at 18:45 hrs I received source information that some persons were assembled near Mayur Pahar Ajodhya with two motor cycles and they were whispering about loot/robbed any tourist vehicle with arms or deadly weapon. So I along with officer and forces namely 1) SI Partha Sarathi Shit, 2) C/610 Achinta Bauri 3) C/564 Prasad Majhi, 4) C/53 Debendranath Majhi & 5) C/480 Mangal Sing all are of Baghmundi PS vide C.C. No-1143/21, Dated- 07.04.2021 left for Ajodhya Hill Top to work out the said information.

I along with force reached at Bagandih More Crossing, Ajodhya Hill Top at 19:50 hrs by keeping the police vehicle (at a distance of 200 meters away (approx), then we approached to the Mayur Pahar at an open space. We heard suspicious human voices at a distance from 25-30 meters to talking amongst themselves. After having heard this I along with forces confronted suspicious character as police party and they tried to flee away from the spot. But we instantly apprehended 04 persons. On being asked they disclosed their identity as noted above. Rest 01-02 persons fled away by one motor cycle from the spot due to the darkness as well as geography of the locality. After apprehending the above noted persons we searched them. During search found 1. One improvised country made iron made one shooter pipe gun having total length – 9.5 inch (Butt-3.5 Inch, Barrel-6 inch) loaded with one live ammunition recovered from the possession of Shikar Chandra Murmu in his west back side in concealed by full pant and shirt, 2. One live ammunition having length 06 CM recovered from the right pant pocket of Shikar Chandra Murmu, 3. One Iron Bhojali having wooden butt length 14.5 inch recovered from the right hand of Tapan Majhi, 4. One Yamaha (Saluto RX) Red and Black colour motor cycle having without registration number recovered from the possession of Tapan Majhi, 5. 01 (One) Iron Rod having length 3 ft 4 Inch recovered from Mutuk Paharia, 6. One black colour steel made folding knife having length 8.5 inch recovered from the right pocket of Paresh Mandi. The above noted articles has been duly seized and prepared seizure list by me and also labeled.

On interrogation the accused persons disclosed their names and address as noted above and stated that they were assembled there for committing dacoity on tourist vehicle of Ajodhya Hill during this night. On demand the above noted miscreant failed to produce any valid license or relevant document of any competent authority in favour of possessing improvised country made iron made one shooter pipe gun and to acquire the same. So, I arrested them informing the ground of arrest, observing all arresting guidelines and seized the above noted articles and labeled them duly signed by the police witnesses as there were no local witnesses available there. As it was evident during our raid the accused persons assembled at a solitary place and were preparing amongst themselves with weapons found in their possessions for committing dacoity on tourist vehicle, actually committed an offence punishable U/S- 399/402 IPC and 25/27 Arms Act. In view of this I arrested the above noted 04 (Four) accused persons and seized the arms, ammunition, weapons and other articles from their possession by preparing seizure list on the spot duly signed by the accused persons as well as witnesses and brought them to P.S.

Hence I do hereby start a specific case against the above noted accused person under proper section of law and arrange its investigation.
