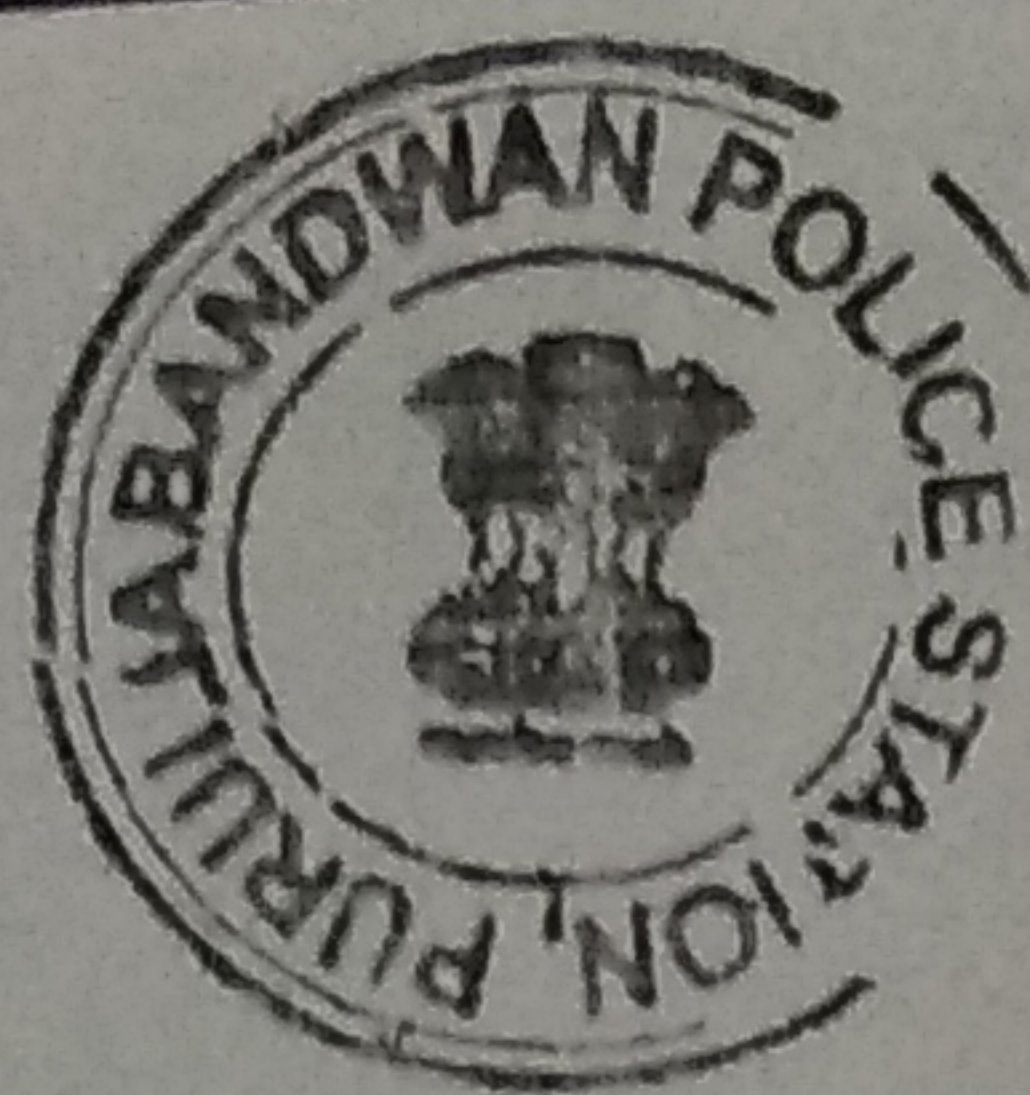

I SI Sukanta Das De of Bandwan PS, beg to state that as per your kind order vide Bandwan PS GDE No-879, Date-29/04/2021 & C.C No-1181/21 Date-29/04/2021, Today i.e. on 29.04.2021 at about 10:05 hrs while myself along with force were performing spl. drive against none wearing mask in such pandemic situation at Bandwan PS area and found the above noted 10 (ten) persons were roaming aimlessly several place by none using mask at Bandwan Bus stand area, Chilla More, Bandwan Bombay Chawk. In course of my duty with the help of accompanied SI Banshi Dhar Mukherjee and C/1139 Jiban Senapati 2) C/922 Sanjoy Bauri all are of Bandwan PS, Dist-Purulia, I intercepted them at above noted places under Bandwan PS area. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to speed of Corona virus (Covid-19). Corona virus is going on throughout the District of Purulia. In this situation they were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. In view of Pandemic of COIVD-19 outbreak the above noted persons were arrested after maintaining all formalities regarding arrest and prepared arrest memos brought them to P.S.

Therefore, I am praying legal action U/S-188/34 IPC & read with section 51 of Disaster Management Act, 2005 may kindly be started against above mentioned accused persons & oblige.
