In producing here with 02 (two) arrested accused persons namely (i) Kousik Mahato (22) S/O Kajal Sir, Mahato of Vill- Manguria, PS-Purulia(M), Dist-Purulia and (ii) Arjun Mahato (21) S/O Manik Chandra Mahato of Vill- Shankhakuri, PO-Sadhar, PS-Chandankeyari, Dist-Bokaro (JKD) and brought under seizure 01 (one) vehicle Dumper having Reg. No.- JH 09AP 7501 ·loaded with sand approx 500 cft. The fact in brief is that today (09/04/2021) during mobile duty vide Jhalda PS CC No- 1011 Dated- 09/04/2021 at Mosina more at about 19:25 hrs received a credible source information that one vehicle (Dumper) having Reg. No JH 09AP 7501 was loaded sand at Shyamnagar Ghat and carrying sand illegally and coming from Shyamnagar ghat & going towards Bokaro under Jharkhand state. Accordingly, myself along with force left to work out the said source information. Then, we went to Jargo more (Jhalda Bagmundi road) under Jhalda PS and started NAKA checking about 100 miters away from Jargo more. Seeing one vehicle coming to Jargo more we gave light and indicated to stop the vehicle. But the vehicle is not stopped and we started chasing. We intercept the said vehicle at Jargo more (Jhalda Bagmundi road) under Jhalda PS at about 20:05 hrs and apprehended 02 (two) persons of the vehicle (Dumper) and it is noticed that the above noted Dumper was loaded with sand (approx 500 cft). On asked the detained persons, one Kousik Mahato stated that he is the driver of the Dumper and disclosed his identity as mentioned above and rest one Arjun Mahato stated that he is the helper (Khalasi) of the Dumper and disclosed his identity as mentioned above. On demand, they failed to produce any valid papers in respect of the Dumper as well as loaded sand though sufficient time was given for produce valid documents/ chaMan. During interrogation, the driver and helper of the said Dumper confessed that they in convince with the owner of said Dumper, Aditya Kumar Mahato S/O Rampada Mahato of Vill- Darpa, PS-Jhalda, Dist-Purulia, Shakti Mahato S/O Lt. Harekrishna Mahato of Vill- Pusti, PS-Jhalda, Dist-Purulia & others are doing this illegal business of sand and they have no Challan/paper for carrying loaded sand. They also confessed that they are doing this illegal business of sand since long in clandestine manner. Then, I arrested accused driver of said vehicle (as disclosed during interrogation) as Kousik Mahato (22) S/O Kajal Mahato of Vill- Manguria, PS-Purulia(M), Dist-Purulia and helper of the said vehicle, Arjun Mahato (21) S/O Manik Chandra Mahato of Vill- Shankhakuri, PO-Sadhar, PS-Chandankeyari, Dist-Bokaro (JKD) under proper arrest memo and also seized vehicle (Dumper) having Reg. No JH 09AP 7501 with loaded sand (approx 500 cft).

On return to P.S., Put the arrested accused persons into the P.S.
