In producing here with 02 (two) arrested accused persons namely (i) Karan Kumhar (41) S/O Henglu Kumhar of Vill- Kumardih, PS- Chandankeyari, Dist-Bokaro (JKD) and (ii) Ajay Sing (21) S/O Satrughana Sing of Vill + PO- Jorobari, PS-Boro, Dist-Purulia and brought under seizure 01 (one) vehicle Dumper having Reg. No.- JH 02AV 2841 loaded with sand approx 500 cft. The fact in brief is that today (09/04/2021) during Spl. evening mobile duty vide Jhalda PS CC No- 1012 Dated- 09/04/2021 at Ichag more at about 19:05 hrs received a credible source information that one vehicle (Dumper) having Reg. No JH 02AV 2841 was loaded sand at Bhusudih Ghat and carrying sand illegally and coming from Bhusudih ghat & going towards Ramgarh under Jharkhand state. Accordingly, myself along with force left to work out the said source information. Then, we went to Pusti more (Jargo Pusti road) under Jhalda PS and started NAKA checking and we intercept the said vehicle at about 19:45 hrs and apprehended 02 (two) persons of the vehicle (Dumper) and it is noticed that the above noted Dumper was loaded with sand (approx 500 cft). On asked the detained persons, one Karan Kumhar stated that he is the driver of the Dumper and disclosed his identity as mentioned above and rest one Ajay Sing stated that he is the helper (Khalasi) of the Dumper and disclosed his identity as mentioned above. On demand, they failed to produce any valid papers in respect of the Dumper as well as loaded sand though sufficient time was given for produce valid documents/ challan. During interrogation, the driver and helper of the said Dumper confessed that they in convince with the owner of said Dumper, Aditya Kumar Mahato S/O Rampada Mahato of Vill- Darpa, PS-Jhalda, Dist-Purulia, Shakti Mahato S/O Lt. Harekrishna Mahato of Vill- Pusti, PS-Jhalda, Dist-Purulia & others are doing this illegal business of sand and they have no Challan/paper for carrying loaded sand. They also confessed that they are doing this illegal business of sand since long in clandestine manner. Then, I arrested accused driver of said vehicle (as disclosed during interrogation) as Karan Kumhar (41) S/O Henglu Kumhar of Vill- Kumardih, PS- Chandankeyari, Dist-Bokaro (JKD) and helper of the said vehicle, Ajay Sing (21) S/O Satrughana Sing of Vill + PO- Jorobari, PS-Boro, Dist-Purulia under proper arrest memo and also seized vehicle (Dumper) having Reg. No JH 02AV 2841 with loaded sand (approx 500 cft).

On return to P.S., Put the arrested accused persons into the P.S. Lock Up after maintaining all formalities, kept the sand loaded seized vehicle (Dumper) at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Karan Kumhar (41) S/O Henglu Kumhar of Vill-Kumardih, PS- Chandankeyari, Dist-Bokaro (JKD) and (ii) Ajay Sing (21) S/O Satrughana Sing of Vill +-PO-Jorobari, PS-Boro, Dist-Purulia, (iii) Owner of the vehicle (Dumper) having Reg. No JH 02AV 2841 (iv) Aditya Kumar Mahato S/O Rampada Mahato of Vill- Darpa, PS-Jhalda, Dist-Purulia, (v) Shakti Mahato S/O Lt.
