NADA checking duty at Jhalda Bus stand under Jhalda PS. During Spl. NADA checking duty as per direction we were engaged for implementation of Govt. order regarding cluster management plan. During Spl. NADA checking duty at 16:25 hrs. at Jhalda Bus stand under Jhalda PS, Dist-Purulia and checked and detained above noted acid persons as they did not wear mask on their face and moving casually without maintaining social distance. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reasons why they came out from house and reached there. So, there is every reason to believe that the said persons came out from their home without wearing mask and maintaining social distance and raising疑问 of making fun and they did not care for emergency purpose. Through National Directive for COVID-19 Management (pinlock-2) is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide order No. 74-C/2020 dt. 12.04.2020 of the Government of West Bengal and Memo No. 046-C/2021 dt. 24.04.2021 for residential norms. As such the above persons violated the order during this pandemic situation duly persecuted by Govt. of West Bengal. Therefore, very disobeyed Govt. order. I arrested above noted acid persons maintaining 21 families of small and large as released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodged against above noted 21 (Twenty One) arrested acid persons as they disobeyed Govt. order regarding epidemic COVID-19 u/s 188 IPC and 51 (1)(b) of Disaster Management Act, 2005 and arrange for investigation.
