

Therefore, I pray a specific case may kindly be lodged against above noted 20 (Twenty) arrested accd. persons as they disobeyed Govt. order regarding epidemic COVID-19 U/S 188 IPC and 51 (1)(b) of Disaster Management Act, 2005 and arrange for investigation.
