Sir,

In producing herewith 02 (two) arrested accused persons namely (1) Manahar Mahato (33 yrs) S/o-Suchand Mahato (2) Vidyadhar Munda (20 yrs) S/o-Radhu Munda both of Vill-Uparbarga, PS-Barlanga, Dist-Ramgarh State-Jharkhand along with seized truck bearing No-JH02F-3738 loaded with sand (300 CFT approx) under proper seizure list, I beg to submit that today (09/04/2021) I along with (1) C/-997 Rajkumar Bauri (2) JC/-1476 Md. Eklakh both of Joypur P.S were performing Special Mobile duty vide Joypur PS CC No-1525/21 Date-09/04/2021. During my mobile duty at about 10:30 hrs I along with force reached at Rakhbor More under Joypur PS and found that a truck having Regd. No- JH02F-3738 loaded with sand was coming from Jhalda side. On seeing the Police party at Rakhbor more, the driver and helper of the said truck were trying to fled away. But after a hot chase, we could able to detain the driver & helper of said truck having No- JH02F-3738. I asked the driver Manahar Mahato to produce valid documents in respect of said sand but they failed to produce any documents regarding lifting & transportation of sand. I interrogated them thoroughly. During interrogation, they admit that they are dealing with illegal sand lifting from Subarnya Rekha riverbed and transporting the sand to Jharkhand area with the help of Shaktipada Mahato S/o-Late Harekrishna Mahato of Vill-Pusti, PS-Jhalda, Dist-Purulia and the owner of the said truck was also involved in this illegal lifting and transportation. They alos stated that said Shaktipada Mahato is the kingpin of illegal sand lifting & transportation racket with help of others from Subarnarekha sand bed to Purulia Dist & Jharkhand. The driver also failed to produce any paper in respect of the truck. Hence, I seized the truck having bearing Regd. No-JH02F-3738 loaded with sand (300 CFT approx) in between 12:25 hrs to 12:45 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested (1) Manahar Mahato (33 yrs) S/o-Suchand Mahato (2) Vidyadhar Munda (20 yrs) S/o-Radhu Munda both of both of Vill-Uparbarga, PS-Barlanga, Dist-Ramgarh State-Jharkhand in between 12:55 hrs to 13:05 hrs. I brought the said truck to Joypur P.S. As such there is every reason to believe that the driver, helper and owner of the vehicle with ill motive are habitually dealing with sand illegally and transport to Jharkhand area without any valid document. So they are liable for offence punishable U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against namely (1) Manahar Mahato (33 yrs) S/o-Suchand Mahato (2) Vidyadhar Munda (20 yrs) S/o-Radhu Munda both of both of Vill-Uparbarga, PS-Barlanga, Dist-Ramgarh State-Jharkhand (3) Shaktipada Mahato S/o-Late Harekrishna Mahato of Vill-Pusti, PS-Jhalda, Dist-Purulia and owner of truck having bearing Regd. No-JH02F-3738 may kindly be started and arrange for its investigation.
