Sir,

In producing herewith 02 (two) arrested accused persons namely (1) Rajesh Mahato (23 yrs) S/o-Bishnu Mahato (2) Mahen Mahato (18 yrs) S/o-Late Manohar Mahato both of Vill-Kenduadih, PS-Jhalda, Dist-Purulia along with seized Dumper bearing No- JH-01CW/4330 loaded with sand (500 CFT approx) under proper seizure list, I beg to submit that today (09/04/2021) I along with (1) C/-946 Sudarshan Bauri (2) C/-45 Samir Kr Mahato both of Joypur P.S were performing Day Mobile duty at Kathaltard under Joypur PS vide Joypur PS CC No-1522/21 Date-09/04/2021. During my Naka duty at about 14:05 hrs I found that a dumper having Regd. No- JH01CW-4330 loaded with sand was coming from Chas more side. On seeing the Police party at Kathaltard Naka point, the driver and helper of the said dumper were trying to fled away. But after a hot chase, we could able to detain the driver & helper of said dumper having No- JH01CW-4330. I asked the driver Rajesh Mahato to produce valid documents in respect of said sand but they failed to produce any documents regarding lifting & transportation of sand. I interrogated them thoroughly. During interrogation, they admit that they are dealing with illegal sand lifting from Subarnya Rekha riverbed and transporting the sand to Jharkhand area with the help of Shaktipada Mahato S/o-Late Harekrishna Mahato of Vill-Pusti, PS-Jhalda, Dist-Purulia and the owner of the said dumper was also involved in this illegal lifting and transportation. They also stated that said Shaktipada Mahato is the kingpin of illegal sand lifting & transportation racket with help of others from Subarnarekha sand bed to Purulia Dist & Jharkhand. The driver also failed to produce any paper in respect of the dumper. Hence, I seized the dumper bearing Regd. No- JH-01CW/4330 loaded with sand (500 CFT approx) in between 15:05 hrs to 15:25 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested (1) Rajesh Mahato (23 yrs) S/o-Bishnu Mahato (2) Mahen Mahato (18 yrs) S/o- Late Manohar Mahato both of Vill-Kenduadih, PS-Jhalda, Dist-Purulia in between 15:35 hrs to 15:45 hrs. I brought the said dumper to Joypur P.S. As such there is every reason to believe that the driver, helper and owner of the vehicle with ill motive are habitually dealing with sand illegally and transport to Jharkhand area without any valid document. So they are liable for offence punishable U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against namely (1) Rajesh Mahato (23 yrs) S/o-Bishnu Mahato (2) Mahen Mahato (18 yrs) S/o- Late Manohar Mahato both of Vill-Kenduadih, PS-Jhalda, Dist-Purulia (3) Shaktipada Mahato S/o-Late Harekrishna Mahato of Vill-Pusti, PS-Jhalda, Dist-Purulia and owner of dumper bearing Regd. No- JH-01CW/4330 may kindly be started and arrange for its investigation.
