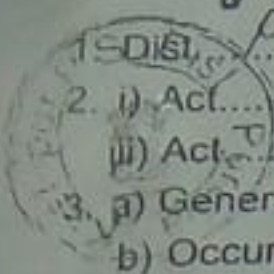

**Sub:-** To lodge FIR against owners and drivers of (i) Mahindra B275 DI (Red Colour) tractor having Regd. number WB81-1429, Engine No RJL2EAN0326, Chassis No MBNABAEAKJRL01681 along with trolley (Without number plate) and (ii) Gromax Trakstar 540 (Blue Colour) tractor having Regd. number WB81-1764, Engine No NJB2DDE2765, Chassis No M9KATACAAJVB00491, along with trolley (Without number plate) each trolleys loaded with sand (approx 40 - 45 Cft.).

Sir,

In producing herewith, 02(Two) tractors i.e. (i) Mahindra B275 DI (Red Colour) tractor having Regd. number WB81-1429, Engine No RJL2EAN0326, Chassis No MBNABAEAKJRL01681 along with trolley (Without number plate) and (ii) Gromax Trakstar 540 (Blue Colour) tractor having Regd. number WB81-1764, Engine No NJB2DDE2765, Chassis No M9KATACAAJVB00491, along with trolley (Without number plate) each trolley loaded with sand (approx 40 - 45 Cft.) and (iii) 02(Two) pieces old Iron made "Belcha" having iron butt before you.

The nub of the fact in a nutshell is that today on 16.04.2021 at 08:40 hrs. I ASI Shyamal Ch. Mandal of Kashipur PS along with (i) C/961 Himangshu Sanigrahi and (ii) C/793 Prasanta Kr. Patra both of Kashipur PS, Dist-Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 448 Dtd - 16.04.2021 and C.C No. 940/2021 Dtd. 16.04.2021. During my mobile duty, I received a tip off at 12:45 hrs. that some persons were loading some tractors with sand from the river bed of Darkeswar River near Chapuri village under Kashipur P.S, Dist- Purulia. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolleys of said 02 (Two) tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Darkeswar River, fled away from the spot. We rushed to the Tractors and detained the said tractors. We searched the said tractors and found that the tractors are loaded with sand (approx 40 - 45 Cft.) each trolleys and also searched surrounding but could not trace out the persons & drivers of said offending Tractors. Hence, seized the above noted 02 (Two) tractors along with trolleys loaded with sand and 02 (Two) pieces old Iron made "Belcha" having iron butt and brought the said seized articles to Kashipur PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted seized tractors along with the trolleys for investigation.
