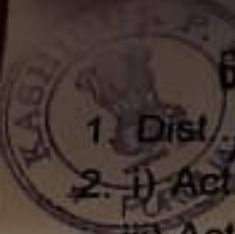

Sub: To lodge FIR against owners and drivers of Sonalika DI 35 (Blue Colour) tractor having Engine No 3100FLU04K986756F18, Chassis No CZJSH991704S3, Without number plate along with trolley (Without number plate) loaded with approx 50 CFT Sand.

Sir,

In producing herewith, 01(One) tractor i.e. (i) Sonalika DI 35 (Blue Colour) tractor having Engine No 3100FLU04K986756F18, Chassis No CZJSH991704S3, Without number plate along with trolley (Without number plate) loaded with approx 50 CFT Sand (ii) 01 piece old Iron made "Belcha" having iron butt and (iii) 01 Iron made "Dhama" before you.

The nub of the fact in a nutshell is that today on 15.04.2021 at 08.45 hrs. I PSI Gourango Roy of Kashipur PS along with (i) C/730 Tapas Mandal and (ii) C/74 Kamakshya Prasad Mandal both of Kashipur PS, Dist-Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 414 Dtd - 15.04.2021 and C.C No. 932/21 Dtd. 15.04.2021. During my mobile duty, I received a tip off at 13.15 hrs. that some persons were loading one tractor with sand from the river bed of Darkeswar River at Shyambathan village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Darkeswar River, fled away from the spot. We rushed to the Tractor and detained the said tractor. We searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending Tractor. Hence, seized the above noted tractor along with trolley loaded with sand and 01 piece old Iron made "Belcha" having iron butt and brought the said seized articles to Kashipur PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted seized tractor along with the trolley for investigation.
