Respected Sir,

In producing herewith 03 (three) arrested accused persons namely (1) Mahendra Munda (27 yrs) S/O- Dubraj Munda of Vill- Koihara, PS- Rajrappa, Dist-Ramgarh (JKD),(2) Pintu Mahato (25 yrs) S/O-Sukdeb Mahato of village Sirka, P.S- Gola, Dist- Ramgarh (JKD),(3) Shaktipada Mahato (47 yrs) S/O- Lt. Harekrishna Mahato of village Pusti, P.S- Jhalda, Dist-Purulia along with seized vehicle (Tipper) bearing No-JH02AQ-3813 with loaded sand aprox 700 cft under proper seizure list, I beg to submit that today (09/04/2021) I ASI Rajib Teyari along with (1) C/427 Tapan Kr. Sahis (2) NVF/-281 Santosh Singha Babu both of Kotshila P.S were performing day mobile duty vide Kotshila PS CC No-810/21 Date-09/04/2021. During my mobile duty at 11.35 hrs I along with force reached at Tali Center More under Kotshila PS and at 11.45 hrs found that a vehicle (Tipper) having Regd. No- JH02AQ-3813 loaded with sand was coming from Jhalda side. On seeing the Police party at Tali Center more, the driver, helper and another one of the said vehicle were trying to flee away. But after a hot chase, we could be able to detain the driver, helper and another one of said vehicle (Tipper) having No- JH02AQ-3813. I asked the driver namely Pintu Mahato (25 yrs) S/O-Sukdeb Mahato of village Shrika, P.S- Gola, Dist- Ramgarh (JKD to produce valid documents in respect of said loaded sand but they failed to produce any documents regarding lifting & transportation of sand. I interrogated them thoroughly. During interrogation, they admitted that they are dealing with illegal sand lifting from Subarnya Rekha river bed and transporting the sand to Jharkhand area with the help of Shaktipada Mahato(47), S/o-Late Harekrishna Mahato of Vill-Pusti, PS-Jhalda, Dist-Purulia and the owner of the said vehicle was also involved in this illegal lifting and transportation. They also stated that said Shaktipada Mahato is the kingpin of illegal sand lifting & transportation racket with help of others from Subarnarekha sand bed to Purulia Dist & Jharkhand and said Shaktipada Mahato is the mastermind of this business with a view to wrongful gain by means of such sand thest. The driver also sailed to produce any paper in respect of the vehicle. Hence, I seized the vehicle(Tipper) having bearing Regd. No- JH02AQ-3813 loaded with sand aprox 700 cft in between 12.05 hrs and 12.35 hrs under proper seizure list in presence of available witnesses duly signed by them and then I arrested (1) Mahendra Munda (27 yrs) S/O- Dubraj Munda of Vill- Koihara, PS- Rajrappa, Dist-Ramgarh(JKD) (2) Pintu Mahato (25 yrs) S/O- Sukdeb Mahato of village Sirka, P.S- Gola, Dist-Ramgarh (JKD) (3) Shaktipada Mahato (47 yrs) S/O- Lt. Harekrishna Mahato of vill-Pusti, PS-Jhalda, Dist-Purulia in between 12.45 hrs and 13.05 hrs .I brought the said seized vehicle loaded with sand and three(03) arrested accused persons to Kotshila P.S. As such there is every reason to believe that the driver, helper, another one Shaktipada Mahato and owner of the vehicle with ill motive are habitually dealing with sand illegally and transport to Jharkhand area without any valid document. So they are liable for offence punishable U/S-379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against namely (1) Mahendra Munda (27 yrs) S/O- Dubraj Munda of Vill- Koihara, PS- Rajrappa, Dist- Ramgarh, Jharkhand (2) Pintu Mahato (25 yrs) S/O- Sukdeb Mahato of village Sirka, P.S- Gola, Dist- Ramgarh, Jharkhand (3) Shaktipada Mahato (47 yrs) S/O- Lt. Harekrishna Mahato of vill-Pusti, PS-Jhalda, Dist-Purulia and registered owner of vehicle (Tipper) having No-JH02AQ-3813 may kindly be started and arrange for its investigation.
