Sir,

I the undersigned would like to lodge this Diary against the accused persons namely 1). Mantu Kumar, son of Jharu Kumar, 2). Fetu Kumar, son of Jharu Kumar, 3). Jharu Kumar, son of Gobardhan Kumar, 4). Binode Kumar, son of Late Chutu Kumar, 5). Saptarishi Kumar, son of Mantu Kumar, all residents of Village+P.O- Tatuara, P.S- Kotshila, District-Purulia, on the following facts:

That I am the Co-Owner and Co-Sharer of the Properties situated at Mouza- Tatuara within this Police Station and more fully described in the below Schedule. The Schedule Properties were/are actually belonged to my grandfather Karnam Kumar and after his death the Properties ultimately devolved upon his four sons namely Fuchu Kumar, Gobardhan Kumar, Gera Kumar and Muchiram Kumar in equal share I am the son of Fuchu Kumar. The Schedule Properties are the joint and ejmal Properties and the same remained as undivided and un-demarcated. The R.S Record of Right is already published in the names of my Predecessors-In-Interest. As the Properties remained ejmal and joint the above named accused persons without having any exclusive right since the last week of March, 2021, began to threatened me and my family with dire consequences and are giving out that they will not allow me and my family to possess the Properties and in-fact hit me with fist and blows and to my elder brother and not only this they also hit my head with one Iron Rod for which I sustained severe injuries and I was under treatment. They also on 05/04/2021 came before me and threatened me and my family members that they will not allow me and my family to exercise our acts of possession and also said that they will sell/alienate the Properties to other persons and after hearing this when I and my elder brother protested they hit me with an Axe on my forehead and also throttled my elder brother's throat and even passed utter and slang languages to my mother who is a Senior Citizen and also threatened me and my family that they will murder us if we further protest and if we not allow then to sell out the Properties I was also admitted to Hospital and underwent surgeries under the guidance of Doctor and also got four stitches at forehead. The Documents issued from the Hospital are enclosed herewith. I say that the above accused have got no exclusive right to sell out the Schedule Properties as the Properties are ejmal and joint Properties and until the Properties are been partitioned they have got no such right to sell and to harass me and iny family members

I, therefore request you Sir to take suitable action against the above accused persons immediately so that I and my family members can stay and pass life peacefully and without

any hindrance and please direct them to not sell the Properties to any person as they have got no such exclusive right to do the same and further register a Criminal proceeding against the above accused persons under appropriate Sections of Law for ill-treating me and my family members
