Sub: Complain to start a specific case.

Sir.

In producing herewith one arrested accused person namely Abhijit Ghosh (23) S/O- Nandalal Ghosh of Vill-Benipur, PS-Neturia, Dist-Purulia along with one seized vehicle Tata ACE Mega bearing registration No-WB 81/1849 loaded with raw coal of 01 MT (Approx) do hereby lodge a complaint to the effect that on 09.04.2021 I, SI Sujoy Kundu, along with C/1140 Dayamoy Mahato and C/1353 Atanu Ganguly all are of Neturia PS were engaged in day mobile duty vide Neturia PS GDE No- 247 Dt. 09.04.2021 & CC No- 770/21 Dt. 09.04.21. In course of day mobile duty, at about 15:05 hrs when we reached at Gobag More, at that time received credible source information that one TATA ACE vehicle bearing registration No- WB 81/1849 loaded with coal coming from Asansol side procuring illegally and trying to transport the same to Raghunathpur side through Purulia - Barakar pitch road in clandestine manner. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force reached at Mekatola rail gate and started Naka checking there. In the mean time at about 15:45 hrs found that the above noted vehicle was coming from Asansol side. We indicated the vehicle to stop and on checking it was found that the vehicle was matched given by source and found that coal seems to be steam was loaded inside of the vehicle. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded coal but he failed to produce any valid documents in support of loaded coal as well as vehicle. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner of the vehicle and owner of coal have procured said coal from different illegal coal mines at different area.

So, it is reasonable to believe that the above noted accused driver, registered owner of the said vehicle and owner of coal have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen, as per their regular practice.

Accordingly, I seized Tata ACE Mega bearing registration No- WB 81/1849 loaded with raw coal of 01 MT (Approx) under proper seizure list duly signed by available witnesses and also I arrested Abhijit Ghosh (23) S/O- Nandalal Ghosh of Vill-Benipur, PS-Neturia, Dist-Purulia (Driver) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him PS with loaded TATA ACE. I have also sealed & labelled approx 05 (Five) kg coal as sample from the major contraband on that spot.

Under the above circumstances a specific case may kindly be started against 1) Abhijit Ghosh (23) S/O- Nandalal Ghosh of Vill-Benipur, PS-Neturia, Dist-Purulia (Driver) (2) Registered owner of vehicle having No- WB 81/1849 and (3) Owner of coal seized from vehicle No- WB 81/1849 under proper section of law.
