The humble petition of the complainant
Most respectfully showeth :-

1. That the complainant is the legally married wife of the accused and their marriage was solemnised according to christian rites, customs and usages prevalent in their community on 10/05/2002 at the maternal uncle's house of the complainant at Village Bodra, P.O./P.S.Salanpur, District-Paschim Bardhaman in presence of their guardians, relatives and well wishers and their said marriage was registered at Benagoria Methodist church, Mugma, Dhanbad(Jharkhand) on the same date i.e. on 10/05/2002 and that at the time of such marriage the complainant's father gave cash of Rs. 1,00,000/- gold ornaments (30 gms) silver 80 gms and that other household articles including furnitures worth Rs. 1,00,000/- to the accused as per his capacity towards bridal gifts.

3. That after few months of the marriage the complainant was subjected to various means of torture in the hands of the accused. The accused asked/forced the complainant to bring Rs. 50,000/- from her father and on protest the accused tortured the complainant both mentally and physically.

4. That on 25/12/2002 the accused again told the complainant to bring Rs. 50,000/- from her father but the complainant refused to do so and protested against her husband's such illegal demand to which the accused assaulted the complainant brutally and ousted the complainant from the matrimonial home after keeping all her stridhans and the complainant became helpless filed one maintenance case against her husband at Asansol court bearing Misc. case No.212/2003 and 05/12/2003 the said case ended mutually by way of compromise and the accused undertook to maintain the complainant properly as his legally married wife and the complainant went again to her matrimonial home along with her husband.

5. That out of the lawful wed-lock they have been blessed with 2 male child namely, Asit Das born in the year 2006 and Biki Das born on 2008.

6. That it is unfortunate to state that although the accused undertook to maintain the complainant properly but the accused was so inhuman that he used to ~~told~~ ^{tell} the complainant to bring Rs. 50,000/- from her father and on protest the accused tortured the complainant both mentally and physically and on 25/12/2020 the accused brought one woman namely, Anita Murmu, D/o Bisweswar Murmu of Village-Mildaha, P.S.Mihijam, District-Jamtora(JH) and started living with her as husband and wife although the marriage in between the complainant and the accused is still subsisting.

7. That on 03/ 01/2021 the accused again told the complainant to bring Rs. 50,000/- from her father and the said lady also supported the accused to which the complainant again protested the illegal demand made by the accused and as a result the accused and the said lady drove out the complainant after merciless assault forcibly keeping the 2 minor sons and the stridhans under their custody and told the complainant that she would not be allowed to stay with the accused if she did not fulfil the demand.

3. That the father and the other persons along with the complainant went to the house of the accused on the next day but neither the accused nor the said lady allowed them to enter into their house to talk with them and finding no other alternative all of them returned back to their house.

9. That on 16/02/2021 at about 10-30 A.M. the accused came by a motor cycle all on a sudden to the paternal house of the complainant at Village-Puapur aforesaid and again demanded Rs. 50,000/- from the complainant to which the latter refused and protested whereupon the O.P. assaulted the complainant by fists and blows kicks on her person in presence of complainant's parents brother and as such the latter tried to save the complainant and ultimately on complainant's cry when the neighbours intervened the accused fled away by his motor cycle with a threatening. The complainant sustained pain all over body due to such assaults and ultimately on 19/02/2021 she got herself treated at Hamardih C.H.C. and also lodged a written complaint before Neturia P.S. on that date, to which the Duty officer ^{assured =} advised to take necessary action against the miscreant but to no result and as such the complainant reported the matter to the Superintendent of Police through postal speed post on 25-02-2021 enclosing the copy of Medical papers and the copy of written F.I.R. dated 16/02/2021 for initiating proper action against the accused but it is painful to state that about a month has elapsed but neither the Neturia P.S. nor the S.P.,Pumulia took any action against the offences so far committed by the accused.

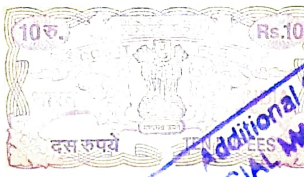
