Complain to start a specific case. Sub:

Sir.

In producing herewith two arrested accused persons namely (1) Susil Singh (39) S/O- Lt. Banarash Singh of Vill-Kangoi, PS-Mihijam, Dist-Jamtara, Jharkhand and (2) Sandip Kumar Singh (37) S/O- Rajendra Singh of Vill-Bhelanari, PS-Govindganj, Dist-East Champaran, Bihar, A/P- Gopalpur, Asansol (S), Dist-Paschim Burdwan along with 03 (three) seized vehicle having registration No- JH 05DA/1115, Engine No-411163391023, Chassis No-MAT466388E1H12350 (Truck), JH 05BG/8286 (Swift) and WB 26R/1368 (Hyundai Verna) do here by lodge a complaint to the effect that on 29,04,2021 at 11:45 hrs SI Kalyan Kumar Sakha, duty officer received a telephonic information that some persons are manipulating the number plate of a truck guarding by above two four wheeler on Sarbari - Madhukunda road near Maithon Steel & Power Ltd. Accordingly he diarized the matter in PS GD and intimated the matter to you over phone and as per your direction he directed me to work out the information. Accordingly I, SI Chandan Kumar Sen, ASI Shibaram Bauri, C/1304 Dhananjoy Mondal, C/1260 Santosh Saren and C/78 Utpal Sarkar all are of Neturia PS, Dist-Purulia proceeded towards Sarbari - Madhukunda Road to work out the information. At about 12:25 hrs while we reached near Murgabani More, we got down from the vehicle and proceeded towards Murgabani - Murulia road on foot near Maithon Steel & Power Ltd. and when we reached near the truck, found two small cars out of it one standing front and one back side of one truck and also found that above noted arrested persons manipulating the registration number of the truck by spraying yellow colour and rest 02 (Two) persons remain present in the said truck, seeing the police party they started to flee away from the spot. We chased them and apprehended the above noted two persons and rest 02 (Two) persons managed to flee away from the spot. At the time of chasing accused Sl. No. (1) fell down and received injury on his head. On being asked they disclosed their identity as noted above. I asked them to produce the original relevant documents in respect of truck having No- JH 05DA/1115 but they failed to produce any documents in respect of truck. I also asked them to produce the relevant documents of vehicle having No- JH 05BG/8286 (Swift) and WB 26R/1368 (Hyundai Verna) but they also failed to produce the same. I searched the truck thoroughly and found that the Engine No-41H63391023 and Chassis No-MAT466388E1H12350 of the truck. Thereafter I seized vehicle having registration No-JH 05DA/1115, Engine No-41H63391023, Chassis No-MAT466388E1H12350 (Truck), JH 05BG/8286 (Swift) and WB 26R/1368 (Hyundai Verna) and one spray container of medium yellow colour marked as AEROSOL LACQUER 950 CUBE under proper seizure list duly signed by the witnesses and arrested the above noted accused persons after maintaining all formalities of arrest. On interrogation they confessed that they have stolen the above noted truck under M.G.M PS, Jamshedpur, Jharkhand and manipulating the number by yellow colour spray to sale the same. I contacted with M.G.M PS, Jamshedpur, Jharkhand and Dy. SP Traffic office Purulia and it came to learn that a specific case has been started at M.G.M PS, Jamshedpur, Jharkhand Vide M.G.M PS Case No- 42/2021 Dt. 19.04.2021 U/S-394 IPC regarding the truck. On consultation it also came to learn that the original registration number of the truck is JH02AD/1477, Engine No-41H63391023, Chassis No-MAT466388E1H12350.

So, it is reasonable to believe that the above noted arrested accused with others forming a racket & hatching a ed truck for and with a motive type of crime. So they have circumstances a specific cas vill-Kangoi, PS-Mihijam, Dist-Jamtara anari, PS-Govindganj, Dist-East Champaran, I ters.
