Sir,

Today on 25.04.2021 at about 06.00 hrs. while I, ASI Md. Wakil Khan along with my force were performing Naka duty near Harai bridge under Para PS, a Truck bearing Regd. No- RJ19GA/4877 were approaching towards the Naka Point from Raghunathpur side, we tried to stop the said vehicle but the driver tried to escape through the barriers. Unfortunately the said Truck fell from the road and capsized while escaping. We rushed to the spot where the Truck was capsized but found Driver and Helper of the said Truck fled away. The Truck was carrying huge quantity of whiskey illegally. Accordingly I informed the matter to O/C Para PS and as per his direction I seized the following articles under proper seizure list in presence of my accompanying police force duly signed by the witnesses. The seizure procedure was done from 06.35 hrs to 08.25 hrs. at the P.O.

- 1) 115 (One hundred and fifteen) boxes of Whiskey labeling as Royal Player of which
  - i) A) 55 (Fifty five) Boxes of Whiskey containing 30 Pcs bottles each and each bottles contains 180 ML whiskey.  
B) 01 (One) bottle of 180 ML whiskey seized as a sample.
  - ii) A) 25 (Twenty five) Boxes of Whiskey containing 24 Pcs bottles each and each bottles contains 375 ML whiskey.  
B) 01 (One) bottle of 375 ML whiskey seized as a sample.
  - iii) A) 35 (Thirty five) Boxes of Whiskey containing 12 Pcs bottles each and each bottles contains 750 ML whiskey.  
B) 01 (One) bottle of 750 ML whiskey seized as a sample.
- 2) One Truck bearing Regd. No- RJ19GA/4877

So, its crystal clear that the owner of the vehicle , the driver and some other persons have been running this illegal business of transporting stolen property in clandestine manner sine long and they are habitual offenders .

Hence I would like to request you to start a specific case against the accd persons (unknown) and arrange for its investigation.
