The fact of the case in a nut shell is that I SI Nimai Nemo along with force namely **1)** C/253 Aurobinda Mallick **2)** C/ 858 Subhas Ch. Punuria was performing the Naka duty and Special Mobile Duty being assisted by ASI Sk Guljar for the implementation of the order of the State Govt. in the area vide Purulia (M) PS GDE No-1147 dtd 29/04/2021 in consonance with C.C No 991/2021 Dtd. 29/04/2021 and 992/2021 dated 29/04/2021 as per order of superior. During my Naka and Special Mobile Duty, while I arrived at Chharrah Xing more at 11:50 hrs and found 24 (twenty four) persons noted in the supra were confabulating among themselves standing beside the road without wearing the mask and maintaining the social distance. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted confabulation beside the road after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021. Subsequently it is pertinent to say that the supra noted persons refused to comply with any direction given by the State Government under The Disaster Management Act. 2005 which is dangerous to life themselves and others. Consequently, the supra noted persons were arrested on the spot and informed them the gourd of their arrest and issued memo of arrest in respect of each persons.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo 486-CS/2021 dtd 24/04/2021 under The Disaster Management Act. 2005 which is dangerous to life of themselves and others so they can be booked U/S 188/34 of the IPC and read with section 51 (b) of The Disaster Management Act 2005. So a specific case may kindly be initiated against them and arranged for its investigation.
