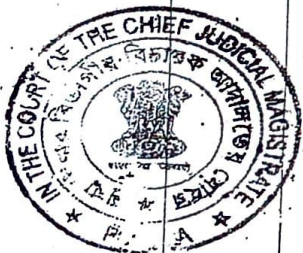

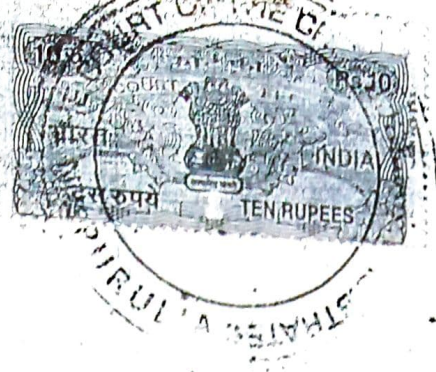

That on 22/02/2021 father of your petitioner driven out to your petitioner from his house and snatched all ornaments belongs to your petitioner along with the pass book, cheque book, aadhaar card, voter card of your petitioner and also original birth certificate and other important documents of the child of your petitioner.
4. That on being repeatedly request/demand of above mentioned articles and documents by your petitioner, the father of your petitioner clearly refused to return anything to your petitioner.
5. That your petitioner is poor lady as there is no one to looked into but your petitioner has to take every care of her child and as the father of your petitioner snatched all ornaments, cheque book and important documents belongs to herself as well as important ID of the child of your petitioner. The accused also misappropriates the golden ornaments of your petitioner, kept with him, therefore committed breach of trust
6. That your petitioner is passing her life in very hardship.
7. That your petitioner tried to lodged a complaint against the accused person, the father of your petitioner, for his wrong full act against your petitioner before appropriate P.S. but Police Officer of the P.S. could not lodge/note any complaint of your petitioner, accordingly, the matter was informed to SP Purulia on 03/03/2021 under proper receipt. The received copy of the letter given to S.P., Purulia is filed herewith, but no action on the part of Police, hence this petition under section 156(3) CrPC to send the same to the officer in charge purulia(T) PS, treating the same as FIR for unearh the wrongdoer so that the accused may be booked and faced the trial in the Court of Law for the ends of justice.
8. That your petitioner prays that necessary search warrant may executed, than all the offences will be clear before the authority.

It is therefore prayed that your Honour will be graciously pleased to send this petition to O/C Purulia(T) P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr.P.C. and to investigate the case in accordance with law and to unearh the wrongdoer so that the accused may be booked and faced the trial in the Court of Law.
