I am a destituted and neglected wife of my husband Smt Ashok Kumar Deoghoria s/o late Nirod Baram Deoghoria, at present residing at Ashu Sahis Lane, police colony, Purulia (Town) within ward NO-1. My marriage with Ashok Kumar Deoghoria was held on 25th Ashad 2006 after performing all religious rites and ceremony. My father's house is at Golamara within P.S.; Purulia (M.F). My husband is a teacher attached to RAB High School, Gangajapur. Out of that wedlock I have been blessed one male child and one female child. My husband used to torture me both physically and mentally and foods and clothes are not given to me and ultimately he drove me. After searching my ornaments on Saturday (3/4/11) in the morning I came before my husband with a request to keep and maintain me but my husband after seeing me became enraged and assaulted by first and blows on different parts of my bodies and he locked my hairs and cast me on the wall. I sustained injury on different parts of my body. My elder brother was with me and ultimately my elder brother got me examine at Saday Hospital Purulia. I am groaning with pain.

Please take suitable action against my husband Ashok Kumar Deoghoria for assaulting and torturing me. My ja namely Rekha Deoghoria provoked my husband to assault and torture me. I bank upon your co-operation.
