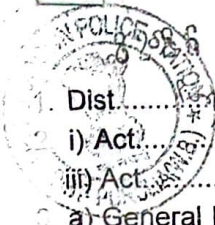

Respected sir,

With due respect I Md. Raja Khan, s/o - Md. Akbar Khan resident of chunabatti, Islam Nagar, S.S Ganguly road, ward NO. - 22, P.O + P.S + Dist. Purulia would like to draw your kind attention towards the unlawful activity taken against me by a particular persons and his family member.

On dated 03.02.2021 approximately ~~near~~ 8:30 AM I was standing near my house. At that point of time SK. Sahil, s/o SK Nizam, of Islam Nagar ward No. - 22 willing started to tease me through various slang languages and also teased me through various unacceptable body language. few moments later when I was busy to ask the cause behind the eye teasing SK. Sahil was ~~accompanied~~ accompanied by his elder brother named as SK. Rohit, s/o SK. Nizam of Islam Nagar ward No. - 22. SK. Rohit and SK. Sahil as mentioned above these two fellow tried to break my patience of not reacting to them in the same language as they were doing to me.

In due course they crossed their threshold limit and both of them slapped me several times against my refusal to accept the slang languages used by them toward my family members including mine too.

The situation limit crossed the controlled limit when they started slapping me. To protect myself I run towards my house. I described the whole situation to my family. When my family member along with me reached that spot at that time they vanished.

Looking at the unlawful activity seriously some of the resident of Islam Nagar, ward No. 22 and my family decided to call for a meeting with a mindset to cool the situation through mutual understanding.

On same date 03.02.2021 approximately 7:30 P.M. Some resident of Islam Nagar, ward No. - 22, Our family member and Sr Sahil's family member came on the same platform for mutual understanding.

Refusing all the talks of the residents of Islam Nagar, ward No. - 22 and of my family members they left the meeting spot and again came back after few moment holding truncheon. They started to beat the persons who attended the meeting with intention to disperse the mob. They used the truncheons severely to beat. P.T.O.

The persons who got injured in this incident and could not handle the truncheons pressure and ~~shoo~~ shocked the body parts are as follows:-

In this fierce incident SK. Kalam s/o - Late SK. Asraf suffered a brain injury and was hospitalised due to which a delay in launching the FIR is seen.

So, its a kind request to take strict action against the culprit.
