I, Basant Kumar khedia, s/o late Binod Kumar khedia, resident of sonu enclave, cooks compound, purulia 723101, would like to bring to your notice that I had entered into an agreement with Mr. suryaprakash baid, s/o late Chandra gupta baid residing at 136, Jessore road, avani oxford, flat no. 3a, phase1, block 2, p.s. lake town, Kolkata 9 for opening a retail garments showroom at purulia city center mall, in the name of city bazaar metro just behind the big bazaar purulia, for which agreement was signed between us at my shop poshak, Chaibasa road, maa Laxmi market, purulia on 1st august 2018.as per the agreement the accused was liable to pay me interest @18% p.a on the invested amount of Rs. 38.10 lakhs along with a profit share of 50% which amounts to interest of Rs. 15 lakhs approx. and profit Rs. 35 lakhs.

But now Mr. suryaprakash baid is trying to avoid payment of interest and profit in a fraudulent manner for which I have sent demand notice through my lawyers at his Kolkata address and those notice were duly served upon him but he did not pay a heed to that and on the contrary he has sent at my address an envelop through postal service putting a blank paper only.

This proves his malified intensions to cheat my lawful claim which tantamount to a fraudulent practice under the prevailing land of law.

In between these issuances of notice he suddenly came to my shop at purulia, poshak, Chaibasa road and threatened me to of dire consequences if I proceed lawfully to claim my dues from him.

On the above context, I hear by request you to treat this letter of complaint as an FIR to start an appropriate police case against the said Mr. suryaprakash baid after proper investigation which we are assured from your end.
