I do hereby submit complaint against Pappu Hela , S/o Pritam Hela of Adra New Building, PS - Adra, Dist.- Purulia to the effect that on 17/04/21 received information that on 08/04/2021 at about 19.00 Hrs one Pappu Hela, S/o Pritam Hela of Adra New Building, PS - Adra, Dist.- Purulia along with one other unknown person came to Manpasand Bar near at Kamaldanga under Raghunathpur PS area with one fire arms and show the fire arms and try to open fire upon one person of Adra P.S area but somehow the fire arms did not work and thereafter the accused person left the bar.

Informed I.C Raghunathpur P.S and as per his direction Myself along with ASI Sanjib Kr Patra, C/844 Tusar Swadagar, C/666 Sanjib Goswami and C/1325 Sunil Kr Mahato left for Manpasand Bar for verify the information. During enquiry from the statement of the Manager of the Manpasand Bar and worker their statement corroborate with the information. Verify the CCTV footage of the bar, from that the information also crystal clear. Pappu Hela S/o Pritam Hela of Adra New Building, PS - Adra carrying / possessing such fire arms and ammunition without any valid license/documents.

I therefore pray that a specific case may kindly be started against the accused person namely Pappu Hela S/o Pritam Hela of Adra New Building, PS - Adra, Dist.- Purulia under proper section of law and arrange its regular investigation.
