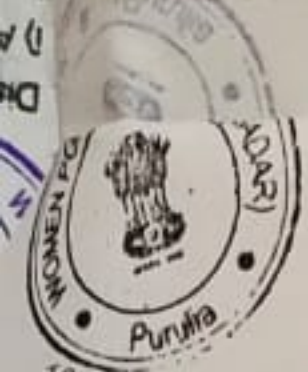

Respected Madam,

I Deepsikha Rewani cravely to place before your kind self the following matter of grave concern for favour of you information and doing the needful.

I am a resident of L.M.Tribedy Lane, Nilkuthi Danga, Purulia. Where my parents namely Dipak Rewani and Mrs. Nita Rewani have been residing.

That as per negotiation my marriage was solicinised with Deepu Kumar son of Ashok Kumar residing in Siddhanath Nagar Gate, Post Japla, District Palamau(Jharkhand), and during the marriage my father had spent huge money for fully decorating the apartment of my husband in Bengaluru.

That since, after the marriage, I had been subjected to persistent physical and mental cruelty and of an on. I was physically assaulted and even burning cigarette butts used to be pressed on different parts of my body causing immense pain and had left indelible scars.

That since, February, 2021 my husband brought me back to his ancestral house at Japla Jharkhand. And since thereafter, I was subjected to all the more cruelty not only at the behest of my husband but also by mother-in-law Mrs. Laxmi Kumar, sister-in-law Mrs. Sunita Singh, father-in-law Mr. Ashok Kumar, brother-in-law Arvind Singh had subjected me to all sort of mental and physical torture and as things exceeded all limits, intimation was sent to my parents to along with others relatives and visited by matrimonial home at Japla at 4th April, 2021. And thereafter I visited local women police station there, and submitted written complain but unfortunately inspite of my earnest request the same was not acted upon and the officer present there insisted me and my parents to withdraw from my complaint.

That the complaint I had written in Hindi and handed over to an officer at Hussainabad women police station was given in xerox to me(photostat form) bearing an endorsement of my husband and I am endorsing a copy of the same for favour of your kind perusal.

That on 5th April, 2021, I was escorted back to my maternal uncle house in Dhanbad where I was medically examined by a private physician.

That I has been under spell of mental trauma and had been thinking as to what steps I would initiate. However, yesterday I received a SMS from the cell phone of my husband where he has given out a threat that he have already instructed a Criminal Case against me, my parents, my maternal uncle and my Maternal Grand-mother.

That my husband is of extreme rowdy temperament and he is trying to subdue me and my parental and maternal uncle family. So, that we do not initiate any complaint against them.
