In producing herewith the accused persons namely (1) Sahidul Sk. (32 yrs) S/O-Lt. Sabir Sk(2) RJS Khan @ Abul (30 yrs) S/O Rabbani Khan (3) Mohan Khan (24 yrs) S/O-Lt. Salauddin Khan & (4) Aslam Khan (38 yrs) S/O- Lt. Punu Khan all of Vill-Mohana, PS-Majia, Dist-Bankura and the seized articles. I SI Gopal Ch. Man of Santuri PS, Dist-Purulia beg to state that during my evening mobile duty vide Santuri PS CC No-1141, Dtd- 16.04.2021 at Madhukunda side received a source information at about 20:35 hrs. to the effect that few veteran accused persons have been seen assembled to the bushy area near Poradiha Adibasipara beside Sarbori to Saltora pitch road suspicious manner with some ill motives. I informed the matter to O/C Santuri PS and as per your kind order I, along with force to work out the information. I reached near the site at about 21:05 hrs and kept the Govt. vehicle No-WB 56C/8993 approx 100 mtr. Away from the site and I along with force walked to the site and more or less cordoned from the back side. I and other force held raid but getting the smell of police, 02 (two) accused persons ran away and after hot chase we could apprehend the above noted accused persons.

I conducted a search to the persons as well as of the place of assembly and found the following articles: -(I) One iron made local pistol with wooden butt length 9.5 inch, (body 4 inch barrel 5 inch, wooden butt 4 inch) loaded with one 9 mm K.F ammunition from the possession of Sahidul Sk. From his waist inside Pant, (II) One Vojali length 18" from the possession of Mohan Khan of his back side waist of inside Pant and one plastic torch light from his hand, (III) One vojali length 16 inch from the possession of RJS Khan @ Abul of his back side waist of inside Pant and one plastic torch light from his hand, (IV) One Vojali length 17 inch from the possession of Aslam Khan of his back side waist of inside Pant and one plastic torch light from his hand, (V) 04 nos of iron made Sabal, (VI) 02 nos of iron made cheni, (VII) 02 nos of hasko Karat with blade, (VIII) 04 nos of iron made hammer with wooden butt, (IX) 06 nos empty Dilkhush country spirit bottle, (X) 06 nos of Plastic glass, (XI) Some half burnt BIRI, (XII) 02 nos of Matches, (XIII) One sack from the place i.e, P.O . Sl. No. 05 to 08 were kept in one sack and Sl. No. 09 to 12 were scattered on the PO.

I have seized and labeled those articles under proper seizure list in between 21:25 hrs and 22:15 hrs on 16.04.2021 and since it was the night and far from the village found no local witness were available during the seizure, as such I prepared the seizure list with police witnesses.

I interrogated the accused persons and revealed their name as above. Interrogations have also revealed that they planned to commit dacoity at the Madhukunda BGVB Bank, at Madhukunda. They all are well known that Sahidul Sk. Possesses an improvised fire arms to operate this crime. I arrested them at 22:25 hrs and onwards respectively. Made arrest memo accordingly, informing them the ground of arrest.

On further interrogation they stated details about the Co-accused persons who were fled away and their where about that they know them as (1) Santi Khan (26yrs) S/O-Sarkar Khan, (2) Sk. Ujir (24yrs) S/o- Katu Khan both of Vill-Mohana, PS-Majia, Dist-Bankura.


As such I submit complaint as against all the Six (06) accused persons, i.e, arrested accused persons namely (1) Sahidul Sk. (32 yrs) S/O-Lt. Sabir Sk(2) RJS Khan @ Abul (30 yrs) S/O Rabbani Khan (3) Mohan Khan (24 yrs) S/O-Lt. Salauddin Khan & (4) Aslam Khan (38 yrs) S/O- Lt. Punu Khan and fled away accused persons namely (5) Santi Khan (26yrs) S/O-Sarkar Khan, (6) Sk. Ujir (24yrs) S/o- Katu Khan all of Vill-Mohana, PO-Bhara Kalibari, PS-Majia, Dist-Bankura with a request to start a case in accordance with law.


