Sir,

In producing herewith one seized vehicle i.e. Tractor DL-740 III SONALIKA INTERNATIONAL bearing Reg. Number-WB 81/0499, & having Chassis No- EZESU508554S3 fitted with Trolley (without number plate) loaded with sand. The fact of the case in brief is that on 25/04/2021 I, A.S.I Ajoy Mukhopadhyay of Santuri P.S along with force were on mobile duty vide Santuri P.S C.C. No. 1212/2021 dtd. 25.04.2021. At about 10:15 hrs received credible source information that the above noted (Tractor) is proceeding towards from backside of Bikash Factory loaded with sand without any valid document to run a clandestine business. After receiving this information we were proceeding towards Damodar river ghat to work out the information. When we reached near Bikash factory side, found that one tractor loaded with sand was coming from Damodar River. On seeing the Police party the driver of the said tractor stopped the tractor in a distance and tried to unload the loaded sand from the said tractor. We rushed to the tractor but the driver then fled away after keeping the tractor on that place at 10:45 hrs. We searched the said tractor and found that the registration No. of the tractor is WB 81/0499, & having Chassis No- EZESU508554S3, tractor is loaded with sand. I searched for any valid documents in respect of loaded sand in the tractor as well as the valid documents in respect of that tractor but nothing found. Hence, I seized the Tractor DL-740 III SONALIKA INTERNATIONAL bearing Reg. Number-WB 81/0499, & having Chassis No- EZESU508554S3 fitted with Trolley (without number plate) loaded with sand under proper seizure list in presence of Police witnesses duly signed by them. I have tried to seize the vehicle in presence of public witness but at that time no any public witness was available. Thereafter, arranging a driver from my source I brought the said tractor to Santuri P.S. As such there is every reason to believe that the driver and owner of the Tractor DL-740 III SONALIKA INTERNATIONAL bearing Reg. Number-WB 81/0499, & having Chassis No- EZESU508554S3 fitted with Trolley (without number plate) with ill motive are transporting sand illegally to run a clandestine business without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.


