Sir,

I, SI Gopal Chandra Man S/O Shri Dhirendranath Man of Vill. Gopinathpur, P.S Beliatore, Dist. Bankura now posted at Santuri PS, Dist- Purulia do hereby produce (1) Lakshan Dhibar (23 yrs) S/O- Budhan Dhibar of Metala, P.S- Chhatna, Dist.- Bankura, (2) Rakesh Dhibar (20 yrs) S/O- Damodar Dhibar of Vill+PS- Santuri, Dist-Purulia (3) Mahesh Bauri (25 yrs) S/O- Manik Bauri of Vill-Mokra (Madhukunda), PS-Santuri,Dist-Purulia & (4) Ranjit Tudu (26 yrs) S/O- Lt Surja Tudu of Vill-Chandurdi, PS-Santuri, Dist-Purulia do hereby lodge a written complaint against them, to the effect that today on 25.04.2021 while I along with C/330 Banamali Soren & C/557 Ambuj Mondal of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 853 dtd. 25.04.2021 vide C.C. No. 1221/21 dtd. 25.04.2021 for implementation of Government rules of Disaster Management Plan and while we reached at Madhukunda bazaar under Santuri P.S, at about 17:45 hrs. found that the above noted persons were gossiping without wearing a facial mask and maintaining social distancing which violates the compliance of norms of wearing of facial mask and maintaining social distancing during this pandemic situation in c/w COVID-19. They violates the Govt. Order vide notification number 347-I.S.S/2M-24/2020 DATED 3rd June, 2020 has under section 2 of the Epidemic diseases Act 1897. So, there is every reason to believe that the above noted persons were moving without wearing a facial mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules. So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused (1) Lakshan Dhibar (23 yrs) S/O- Budhan Dhibar of Metyali, P.S- Chhatna, Dist.- Bankura, (2) Rakesh Dhibar (20 yrs) S/O- Damodar Dhibar of Vill+PS- Santuri, Dist-Purulia (3) Mahesh Bauri (25 yrs) S/O- Manik Bauri of Vill-Mokra(Madhukunda), PS-Santuri,Dist-Purulia (4) Ranjit Tudu (26 yrs) S/O- Lt Surja Tudu of Vill-Chandurdi, PS-Santuri, Dist-Purulia under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
