TVS 4 Storke (being No: WB-38N 4997) through village road of Hansdima at the relevant point of time.

While complainant reached last part of Handima village road all on a sudden got struck by the Accused persons, who already laid trap for the complainant and forcibly got the complaint and his wife down from the motor cycle and snatched the said motor cycle from the complaint in broad day light . Needless to say complaint got hardly chance to raise his protest as a result Accused persons assaulted the complaint and his wife and fell complt's wife on the ground by pulling her hair with utterance ^{of Slang and objectionable words,}

2. That accused persons also snatched an amount of Rs.1600/- from the complaint along with Motor cycle stated above before the left the place of occurrence. Accused also gave out threat that life of complt, would be elevated if complt. had dare to lodge any complaint with any police station against them. As a result being frightened complt. and his wife residing under the mercy of relative at Belbaid colliery .

3. That pertinent to note that vehicle snatched by the Accused persons stands in the name of Parimal Mandal i.e. son of the complaint and having taken away the said vehicle Accused persons have kept said vehicle with ^{original} documents under their custody and using the same for illegal purpose .

4. That due to life threatening from accused persons complt. could not lodge the complaint with Santuri P.S. against the accused person immediate after incident .

5. That complaint informed the incident to Santuri P.S. on 8/02/2021 but no effect. Thereafter complaint informed his grievance to the Superintendent of Police, Purulia through Regd. post on 23/2/2021 but till date no action has yet been taken to give effect the grievance of complaint. Thus finding no other alternative complaint seeks his remedy before the Ld. court.

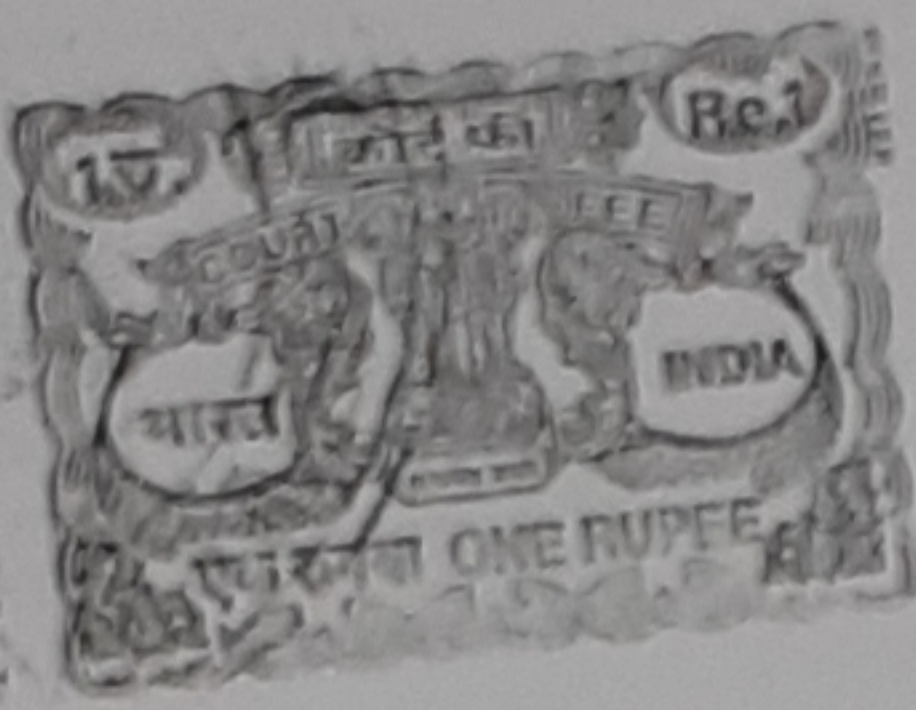
