The above named complainant most respectfully beg to state:-

- That the accused No. 1 is the brother of the complainant and accused no. 2 is the mother of the complainant.
- 2. That Sudhir Gorai since deceased S/o Late haripada Gorai was the father of the complainant and accused No. 1 and Husband of the accused No.2 who held ,owned and possessed some landed properties both the mouzas , Sadhu saltora and Manpur Mouza under Santuri Ps. Within the district of Purulia which are specifically mentioned in the schedule below & ROR had been prepared in his name.
- 3. That said deceased Sudhir Gorai Expired on 3/3/2020 ,leaving behind him the complainant ,the accused no. 1 & 2 and his another son Ujjal Gorai as his only legal heirs and successors who jointly inherited the property mentioned below after the death of their predecessors in interest Sudhir Gorai.
- 4. That after the death of the father of the complainant ,the accused No.1 & 2 hatched up on plan to grab the entire property mentioned below left by Sudhir Gorai depriving the other heirs of the deceased father of the complainant Sudhir Gorai,
- 5. That being driven by above said motive, the accused No.1 & 2 in collution with accused No.3 manufactured a false heir ship certificate of deceased Sudhir Gorai showing and citing there-in that Sudhir Gorai expired leaving behind him the accused No.2 as his only legal heir & successors on -14/07/2020 issued by accused No.3 as pradhan from his office.
- 6. That the accused No.1 on the strength of above said false heirship certificate issued by accused No.3 from his gram panchayet office, in collution aid and abetment of accused No.2 manufactured an another document as Affidavit by swearing false statement before J.M (1st.) as Asansol on 16/7/2020 stating therein that the accused No.2 is the only heir and legal representative of accused Sudhir Gorai being his only widow and there is/are no any heirs of deceased Sudhir Gorai.
- 7. That being armed with the above said manufactured false documents and in collusion with & in active aid and abetment of other accused persons the accused No.1 caused the illegal recording of the land mention below in the





name of accused no.2 only with intent to grab the property from his mother in future by way of transfer of Gift, thus the accused persons have committed offence under section

8. That having learnt the above said misdeed and illegal act of the accused persons, the complainant lodged complaint before Santuri Ps. On 10/02/2021 while police of Santuri Ps. Took no action, the complainant lodged complaint before S.P Purulia on 19/02/2021 in spite of that police took no action against the accused person till this day hence the complainant has been compelled to come before your Honour.

It is therefore prayed that the instant complaint may kindly be sent to O/C Santuri Ps. For investigation after treating the complaint as FIR Under section 156(3)Cr.P.C for the Ends of Justice.
