Sir,

With due respect and humble submission, I beg to submit that I SI Subrata Patra along with C/233 Upananda Das and C/1424 Bhairab Patra all of Santuri PS while performing mobile duty on 27.04.2021 at 20:15 hrs received a credible source information that some persons are transporting coal by their scooters towards Talberia through Baranti Dam pitch road which has been procured by means of theft or any fraudulent manner. After receiving the said information we have started towards Muradi village on that road under our P.S jurisdiction with a view to intercept the said vehicles. At about 20:45 hrs. we found on the foot hill of Baranti Hill in busy area 04 (four) scooters loaded with coal in a respective sack are felt down. On reaching to the spot and searching those scooters but neither any Registration number nor any Engine number or Chassis number could be found. It is reasonable to believe that the owner, driver of said vehicles and others collected the said coal either theft or by any illegally means and transporting to run clandestine business for wrongful gains. So, I have seized the said scooters along with coal under proper seizure list. There was no such public witness available at the time of seizure. Thereafter arranging a public driver I brought the seized scooters along with coal at Santuri P.S compound.

I therefore pray before you to lodge a specific case against the owner, driver of the scooters and others under proper section of law.
