Sir,

In producing here with one arrested accused namely Ajay Shaw @ Bachu (39 Yrs) S/O Baidyanath Shaw of Vill- Laldanga, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 40 bottles (in sealed condition) DIL KHUSH country spirit, 300-ml each bottle, Rs-25 of each bottle.

I SI Joydev Mondal of Adra PS do here by lodged a complaint against accused namely Ajay Shaw @ Bachu (39 Yrs) S/O Baidyanath Shaw of Vill-Laldanga, PS-Adra, Dist- Purulia to the effect that on 22/05/21 at about 17:15 hrs I received a telephonic information from a reliable source that one Ajay Shaw @ Bachu has been stock of country spirit illegally at his Shop at Mama More Adra. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS GDE No-742 dtd.22.05.21. I reached at Mama More Adra at about 17:45 hrs and hold raid in the Shop of said Ajay Shaw @ Bachu and found that the said person selling liquor at his shop and after seeing the Police party some person fled away and said Ajay Shaw @ Bachu has try to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Ajay Shaw @ Bachu selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Ajay Shaw @ Bachu (39 Yrs) S/O Baidyanath Shaw of Vill-Laldanga, PS-Adra, Dist- Purulia under proper section of law.
