
I am producing herewith following arrested accused persons for the fact that, today (10.05.2021) during my mobile duty (Arsha PS GDE No. 309 dtd 10.05.2021) with (i) C/306 Rahuldev Bhunia (ii) C/ 936 Hiru Sar both of SAP 7th BN Camp at Arsha PS vide Arsha PS CC No. 1034/21 dtd 10.05.2021 had been at Arsha Market and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all of them violated the Govt. Order during this Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 17.45 hrs to 18.35 hrs and brought to PS.
