I am producing herewith following arrested accused persons for the fact that, today (24.05.2021) during my Special mobile duty (Arsha PS GDE No. 750 dtd 24.05.2021) with (i) C/970 Dolon Biswas of Arsha PS (ii) C/28 Dipak Dolui (iii) C/970 Kartik Jana both of SAP 7<sup>th</sup> BN Camp at Arsha PS area vide Arsha PS Spl. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all of them violated the Govt. Order during this Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 17.10 hrs to 18.55 hrs and brought to PS.
