





Sir,

I am producing herewith following arrested accused persons for the fact that, today (16.05.2021) during my mobile duty (Arsha PS GDE No. 491 dtd 16.05.2021) with (i) C/236 Akhil Mitra (ii) C/252 Anil Tamang (iii) C/257 Animesh Rout all of SAP 7<sup>th</sup> BN Camp at Arsha PS vide Arsha PS Spl. CC No. 79/21 dtd 16.05.2021 had been at Mishirdih more and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all of them violated the Govt. Order during this Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 17.05 hrs to 18.35 hrs and brought to PS.
