Group Purulia District) under Baghmundi PS, Dist-Purulia were performing mobile duty vide Suisa OP GDE No- 320, Dated- 13.05.2021. During my mobile duty when myself along with force reached at Tilakdhil Kalimandir side at 17.25 hrs and found above persons were roaming aimlessly at Tilakdhil Kalimandir side without mask or its alternative. I detained them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the State Govt. has passed order to wear mask in the public places mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt. is Memo No-486-CS/2021, Dtd: 24.04.2021.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request.


Hence I pray before you to start a specific case against the above noted persons under proper section of law and arrange it investigation.
