I PSI Anupam Garain of Bandwan PS, beg to state that as per your kind order vide Bandwan PS GDE No-241, Dated- 07/05/21 and CC No-1229/21, Dtd-07/05/21, today i.e. on 07/05/21 at about 13:25 hrs while myself along with force were performing Day mobile duty and checking non- wearing mask in such pandemic situation at Bandwan PS area and found the above noted 06 (six) persons were roaming aimlessly by none using mask at Bandwan Bus stand. In course of my duty with the help of accompanied C/515 Bappa Biswas and C/361 Ashit Kundu both of SAP 13th Bn. Barjora, Bankura presently camp at Bandwan PS, Dist-Purulia, I intercepted them at above noted place under Bandwan PS area. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to speed of Corona virus (Covid-19). Corona virus is going on throughout the District of Purulia. In this situation they were refuses to comply the direction given by the Central Govt. & State Govt. vide Order No. 629-ISS/2M-22/2020, Dtd-05/05/21 to combat the severity of COVID-19 pandemic. In view of Pandemic of COIVD-19 outbreak the above noted persons were arrested after maintaining all formalities regarding arrest and prepared arrest memos brought them to P.S.


