When he fail to find me his started shouting in very bad manner with slang languages. Then he kiked chairs and tables in the office. Some time later again he entered in the office and kicked few computers in the office.

These kinds of incidents also happened earlier on 01-03-2021 but no action taken against him. But now it is getting dangerous as he started repeating itself. This have caused missing & damage of important documents.

He sent to Barabaraz BPHC on detelment vide memo no 349/1(4) dt29-12-2020 as per order received from CMOH Purulia vide memo no 2454-1/7 dt.28-12-2020. He was order to vacant the quarter vide memo no 48-1(3)/BND/BPHC dt.15-02-2021 due to non compliance as per earlier order. Since then he is in unauthorized stay in that quarter.

Please take action on this regard from your end and vacant the quarter as early as possible so that BPHC can run properly & work in safe enverionment.
