Ankur of Tulsidih all of PS-Bandwan, Dist-Purulia, I SI Sukanta Das De of Bandwan PS, beg to state that as per your kind order vide Bandwan PS GDE No-487, Date-13/05/2021 & C.C No-1281/21 Date-13/05/2021, Today i.e. on 13.05.2021 at about 07.45 hrs while myself along with force were performing Spl. drive against non wearing mask in such pandemic situation at Bandwan PS area and on 13/05/21 at 14.05 hrs to 15.55 hrs I found the above noted 09 (nine) persons were roaming aimlessly several place by non using mask at Bandwan Chawak bazar, Bandwan Bombay Chawk, Chilla More., In course of my duty with the help of accompanied C/76 Sahab Ram Murmu 2) C/612 Subhajit Roy C/ 1149 Jiban Sanapati, C/922 Sanjoy Bauri all are of Bandwan PS, Dist-Purulia, I intercepted them at above noted places under Bandwan PS area. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to speed of Corona virus (Covid-19). Corona virus is going on throughout the District of Purulia. In this situation they were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic and violated the protocol and restriction to curd down the pandemic situation reference order No. 629-155/2M-22/2020, dtd-05/05/2021. In view of Pandemic of COIVD-19 outbreak the above noted persons were arrested after maintaining all formalities regarding arrest and prepared arrest memos brought them to P.S.

So, I pray that a specific case U/S-188/34 IPC & read with section 51 of Disaster Management Act, 2005 may kindly be started against above noted accused persons and to arrange for its investigation.
