In course of my duty with the help of accompanied ASI Sujit Mondal of Bandwan PS, Dist-Purulia, C/654 Kishore Mal & C/561 Asit Kundu both of SAP 13<sup>th</sup> Bn. Barjora, Bankura A/P-Camp at Bandwan PS, Dist-Purulia, I intercepted them at Bandwan Chawk Bazar under Bandwan PS. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to speed of Corona virus (Covid-19). Corona virus is going on throughout the District of Purulia. In this situation they were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic and violated the protocol and restriction to curd down the pandemic situation reference order No. 647-ISS/2M-22/2020, dtd-15/05/2021. In view of Pandemic of COIVD-19 outbreak the above noted persons were arrested after maintaining all formalities regarding arrest rules and prepared arrest memos brought them to P.S.

So, I pray that a specific case U/S-188/34 IPC & read with section 51 of Disaster Management Act, 2005 may kindly be started against above noted accused persons and to arrange for its investigation.
