Sir,

In producing here with 10 (Ten) arrested persons namely (i) Ambuj Mandi (45 Yrs) S/o- Lt. Balahari Mandi of VIII- Gobindapur (ii) Bipan Soren (35 Yrs) S/o- Matilal Soren of VIII- Puljanga (iii) Bibhuti @ Bivishan Sahis (41 Yrs) S/o- Lt. Lambodar Sahis of VIII- Durku all of PS- Barabazar, Dist- Purulia (Iv) Madhyam Roy (24 Yrs) S/o- Jagannath Roy of Vill- Kalaboni, PS- Hura, Dist- Purulia & (v) Samir Sabar (24 Yrs) S/o- Lt. Yudhisthir Sahis (vi) Bikash Mahato (22 Yrs) S/o- Nimai Mahato (vii) Srinath Karmakar (21 Yrs) S/o- Anil Karmakar (viil) Sunil Majhi (29 Yrs) S/o- Lt. Kirttibus Majhi all are of Vill- Chotoparasiya, PS- Bandwan, Dist- Purulia (ix) Brıhaspati Kumbhakar (18 Yrs) S/o- Anil Kumbhakar (x) Dulal Kumbhakar (22 Yrs) S/o- Bhikamdar Kumbhakar both of VIII- Barasusni, PS- Boram, Dist- East Singhbhum, Jharkhand along with Arrest Memos and other relevant papers.

I beg to state that on (09.05.2021), I was directed to find out whether the COVID protocol has been implanted properly at Barabazar Market area or not. This refers to Barabazar PS GDE No- 407 Dtd. 09.05.2021. Accordingly, myself along with available officers & force had been to Barabazar PS area. At around 15.05 hrs I found that a gathering appeared at Bamnidih village morh without wearing of face mask and seen the Police party some of them tried to fled away. After that as per order we detained the above noted persons.

I introduced myself and ask for their identity. They disclosed their identity as noted above. On interrogation these persons stated their identification but failed to give any satisfactory answer for their such act of violating govt orders. I asked them reason for none wearing of mask in Covid-19 pandemic situation. They falled to explain any valid reason for non-wearing of mask in spite of govt. order in public places. Their negligent act likely to spread infection of disease, dangerous to life of human being. All persons also failed to give any satisfactory answer for such type of movement in indiscipline manner. They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated the Government order vide Memo No- 486-CS/2021 Dtd. 24.04.2021 of the Govt. of WB.

Accordingly, I arrested them for Disobedience to order duly promulgated by public servant; after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. They also violated the norms of disaster management.

All the process was done in between 15.15 hrs and 16.05 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was pandemic situation in the town the peoples left the place and did not agreed to come forward to remain present as witness in the process. I alsorefrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

After that we left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to I.C Barabazar PS through duty officer SI Basudeb Acharya Pan for taking necessary action as per law. I handed over all the relevant papers, Arrest Memos.
