On 2/6/2019, 29/7/2019, 18/4/2020, 30/7/2019, and lastly on 25/2/2021 at the Complainant's house at Village Susunia, P.O. Kumari, within Boro P.S., District Purulia, W.B. Pin Code No. 723131.

D)Name and Address of witnesses:

The humble petition on behalf of the above named Complainant,

Most respectfully begs to state:

- 1) That the Complainant above named is an Asst. Teacher in Economics on contractual basis at Aklavya Model Residential School, situated at Vill. Susunia, P.O. Kumari, P.S. Boro, District Purulia, W.B. Pin Code No. 723131 and he used to resides at his school quarter.
- 2) That the Complainant was married with one Runu Das d/o Abhay Das of Vill. Bhabanipur, P.O. Dhatrigram, P.S. Kalna, District Purba Bardhaman W.B. who is the Accused Person No.1 and their marriage was solemnized on 27/01/2019 according to Hindu rites and customs.
- 3) That since after marriage the Accused Person No.1 used to start ill behave with the Complainant and his parents with the plea that all the properties would be transferred in her name so that his sisters will not get any share thereof and she also threatened that the payment of remuneration will not be given to the parents of the Complainant as well as he will not keep any relation with his relatives.







- 4) That the Accused Person No.1 also hate the Complainant as he is not fair looking and smart and as such she off and on insulted him and uttered ugly languages and also tortured him both physically and mentally.
- That for the above reasons, the Complainant took her into his school quarter but she also started physical and mental torture upon him and due to threatening and out of fear the Complainant was compelled to do every work in the quarter as a domestic servant and on protest the Accused Person No.1 would not hesitate to assault him.
- 6) That the Complainant always tried to maintain his wife properly and regularly as per her will, consent and choice even he spent monies for her competitive examination.
- That when the Complainant and the Accused Person No.1 were in the native village on 2/6/2019 at about 8.30 P.M. the Accused Person No.1 thrown hot tea towards the Complainant and his parents and on asking the reason , she assaulted the father of the Complainant by his walking stick and also throttling his neck but the Complainant and his father somehow escaped by the mother of the Complainant from her hands and on that very night the Complainant's wife also tried to cut the Complainant by bonty and for that he somehow flewed away there from but her wife threatened him with dire consequences.
- 8) That on 29/07/2019 at about 7 P.M. in the evening the Accused No.1 along with her family relatives namely Abhay Das Accused No.2, Smt Mithu Das Accused No.3, Smt Anamika Mondal Accused No.4, Sri Chandan Koley accused No.5, Smt Arpirta Koley accused No. 6, Arati Koledy Accused No. 7, Sri Madan Mohan Koley accused No. 8, Sri Subhasish Sen accused No. 9, Smt. Dipa Sen accused No.10, Sri Gour Mohan Sen accused No.11 came to the spot and by conspiracy with each others entered into the Complainant's Quarter through the open boundary wall on the Northern back side of the same and when the Complainant after completion of his duty returned to his quarter, they all started quarrel with the Complainant on different issues and also








abused him in filthy languages, at midnight about 1.30 A.M. the Accused No.1 tried to murder the Complainant with a sickle in her hand as well as the other members also assaulted him by kicks and blows and also by lathis and for that the Complainant sustained physical injury on his parts. They also threatened the Complainant to kill him on the said night. There after the Complainant became senseless. The said persons as well as the Accused No.1 flewed away from the quarter at about dawn and when on 30/7/2019 the Complainant regained his sense he found the Accused Persons had taken away cash of Rs.15,000/-, one golden neck chain and one finger ring by opening the almirah of the Complainant.

- 9) That as the Complainant was sustained physical injury so he treated at Basantapur P.H.C. as well as by Dr. Arup Kumar Das of Kalna, Burdwan and Dr. Subhankar Nandy of Kalna.
- 10) That thereafter on 18/4/2020 when the Complainant was near the area of Kalyanpur, aforesaid Chandan Koley and Madan Mohan Koley, the Accused No.5 and 8 both assaulted the Complainant and his mother physically and also threatened them and for that the mother of the Complainant was sustained physical injury and she was also treated by doctor.
- 11) That thereafter Accused No.1 and her relatives used to threat the Complainant over phone, And even on 25/2/2021 the Accused Persons came to the residence of the Complainant at Village Susunia and assaulted him by fist and blows and threatened him that they will come again to kill him.
- 12) That in such circumstances the Complainant have been sustained very mental pain and agony and his parents who have been suffering from various ailments due to their old age conditions as well as the Complainant is passing his days with great fear and he also apprehend that his wife and her family members will cause mischief in near future and for that the Complainant on 26/02/2021 had been to





Boro P.S. with a view lodge written complaint to that effect but the Police of Boro P.S. refused to take any complaint from the Complainant then the Complainant sent one written complaint on 04/03/2021 to the O.C. Boro P.S. by registered post with A/D but inspite of receipt of the same as Police did not take any steps against the Accused Persons after elapse of a considerable time so the Complainant again on 19/03/2021 sent another written complaint to the S.P. Purulia stating the entire facts and also requested for taking necessary action to that effect but again inspite of receipt of the same no fruitful result has yet been come out and as such finds no other alternative but the Complainant has been compelled to file this petition before this Ld. Court for seeking relief as per law.

- 13) That the Accused Persons have been committed mischief in collusion with each other which shows their malafide and criminal intention and for their such illegal acts they are rendering themselves liable to be prosecuted for the offences punishable under the law.
- 14) That the Complainant is a very simple law abiding citizen and has no adequate means to file a regular case as well as to incur the expenses of the court cases in regular and proper way.

It is therefore, prayed that your honour would be graciously pleased to send this petition of complainant to the O.C. Boro P.S. as contemplated

U/S 156(3) Cr.P.C. for investigation after treating it as F.I.R. been the interest of justice.
