

The Complainant above-named begs to state as follows:-

1.... That the Complainant and Accused persons are permanent resident of Village Keshargarh,within P.S. Hura,District Purulia and within the jurisdiction of this Ld.Court.

2... That the Complainant is a very poor man and practically is a landless person for which the Government granted PATTA in favour of father of the complainant .And in course of possession in the land the Complainant has planted some Sonaijuri trees over the same and using those trees in various ways having his right & possession over the same.On the other hand the accused persons have no right or possession over the land including those trees.

3.... That on the date of occurrence i.e.on 5.3.2021 Corresponding to 20th Falgun 1427 B.S.at about 10 A.M. all the above-named accused persons armed with Lathi, Axe,& Katari criminally trespassed in to the aforesaid land of the Complainant and started to cut Sonaijuri trees .Hearing thee sound of cutting trees the Complainant rushed to the spot ~~and~~ and protested such illegal acts of the accused persons.

Then the accused persons abused the complainant in filthy languages and there was some sorts of hot altercation in between the parties .And in course thereof the accused persons all on a sudden assaulted

the Complainant with fists and blows & lathi for which the complainant sustained minor injuries on his persons.

Thereafter the accused persons forcibly cut and took away Four Sonaijuri trees from the place the value of those trees is about Rs.30,000/- (Rupees Thirty thousand).

4.. That the Complainant reported the incident in writing to the O.C. Local Police Station as well as the superintendent of Police, Purulia .But as the Police did not have taken any legal steps against the accused persons under the law for which the Complainant is filed this Complaint before the Ld.Court following the provisions of law.

In this circumstances it is prayed that Your Honour may be pleased to send this Complaint to the O.C.Hura P.S. for investigation to treat the same as F.I.R.
