Today (10.05.2021) I SI Sarif Ali Khan along with C/633 Dasarath Sing Mura and JC/1575 Uttam Kr. Mandal were performing Day mobile duty vide Hura PS GDE No- 360 Dated- 10.05.2021 and CC No 1088/21 dtd. 10.05.2021 and as per direction we were engaged for implementation of Govt. rules regarding use of face mask and disaster management plan. At about 16.25 hrs, when myself along with force reached at Bishpuria Morh on NH60A (Bankura – Purulia pitch road) area under Hura P.S. we found 11 (eleven) persons namely 1. Pradip Kr. Mandi S/O- Buddheswar Mandi of Vill- Kumardih, PS- Hura 2. Tapas Mahato S/O- Arjun Ch. Mahato of Vill- Chholagora, PS- Hura 3. Deben Ch. Mahato S/O- Indrajit Mahato of Vill- Bishpuria, PS- Hura 4. Nazim Ansary S/O- Lt. Ramjan Ansary of Vill- Lalpur, PS- Hura 5. Biswanath Murmu S/O- Murari Murmu of Vill- Dariakata, PS- Hura 6. Siddik Ansary S/O- Lt. Kudrat Ansary of Vill- Deoli (Kustuka), PS- Purulia (M) 7. SK. Tahamul S/O- Sk. Tajamul of Vill- Hutmura (Kustuka), PS- Purulia (M) 8. Sk. Samsuddin S/O- Lt. Sk. We warned them regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but they did not pay any heed and also making chaos with the Police party. So finding no alternatives we arrested the above noted 11 (eleven) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 11 (eleven) persons came out from their home without having mask and moving aimlessly without any valid reason for making fun. In view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 and 17.04.2021 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 and 283-CS/2020 dated 21.07.2020 and 486-CS/2021 dated 24.04.2021. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case U/S- 188/34 IPC & Read with section 51(i)(b) of National Disaster Management Act, 2005 may kindly be started against 11 (eleven) arrested persons namely 1. Pradip Kr. Mandi S/O- Buddheswar Mandi of Vill- Kumardih, PS- Hura 2. Tapas Mahato S/O- Arjun Ch. Mahato of Vill- Chholagora, PS- Hura 3. Deben Ch. Mahato S/O- Indrajit Mahato of Vill- Bishpuria, PS- Hura 4. Nazim Ansary S/O- Lt. Ramjan Ansary of Vill- Lalpur, PS- Hura 5. Biswanath Murmu S/O- Murari Murmu of Vill- Dariakata, PS- Hura 6. Siddik Ansary S/O- Lt. Kudrat Ansary of Vill- Deoli (Kustuka), PS- Purulia (M) 7. SK. Tahamul S/O- Sk. Tajamul of Vill- Hutmura (Kustuka), PS- Purulia (M) 8. Sk. Samsuddin S/O- Lt. Sk.
