Sir,

I Sri Anupam Bhattacharjee, B.L & L.R.O. Hura, do hereby lodge complaint against Sushil Kumar Hasda of village Kalipur, under the jurisdiction of Hura PS, Dist. Purulia, who had extracted and stored sand about 5000 to 6000 cft which is minor minerals from Kalipur(Land schedule mentioned below) without having any Quarry Permit, as required under the law which is contravention of the provision of the Rule 4(1) of W.B.M.M. Rules, 2002, and the Rule 3 of W.B. Minerals(Prevention of Illegal Mining, Transportation and Storage) Rules, 2002 and thus committed theft of 5000 to 6000 cft sand which is punishable u/s 379 of IPC. A joint raid programme with the Police personnel of Hura PS was held on 05.05.2021. Sri Gangaprasad Karmakar , Revenue Officer of the Office of the undersigned and Police seized the stored sand(Photocopy of seizure list is enclosed).

Such unauthorised extraction and storing of minor minerals makes the person mentioned above liable to be prosecuted under the Rule 33 of the W.B.M.M. Rules 2002 read with section 21(2) of the Mines and Minerals(Regulation and Development) Act,1957, Rule 5(4)(iv) W.B. (prevention of illegal mining, Transportation and Storage) and under section 379 of IPC.

I would therefore request you to treat this complaint as F.I.R. and prosecute the offender under the law in force and take necessary action for proper investigation.
