NAKA checking duty at Tulin Subarnarekha Bridge under Jhalda PS. During Spl. NAKA checking duty as per direction we were engaged for implementation of Govt. rules regarding disaster management plan. During Spl. NAKA checking duty at 14:45 hrs. at Tulin Subarnarekha Bridge under Jhalda PS, Dist-Purulia and checked and detained above noted accd. persons as they did not wear mask on their face and moving casually without maintaining social distance. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. So, there is every reason to believe that the accd. persons came out from their home without wearing mask and maintaining social distance and moving aimlessly or making fun and they did not come for emergency purpose. Though National Directive for COVID-19 Management (Unlock-2) is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide order No- 79-CS/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 846-CS/2021 dtd. 24.04.2021 for restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal. Therefore, they disobeyed Govt. order. I arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodged against above noted 59 (Fifty Nine) arrested accd. persons as they disobeyed Govt. order regarding epidemic COVID-19 U/S 188 IPC and 51 (1)(b) of Disaster Management Act, 2005 and arrange for investigation.
