Sir,

I, SI Probodh Kr. Mahata of Jhalda P.S. returned to PS with force and brought under seizure 1) One black colour Hero Honda Motor Cycle having Reg. No- JH09D-8372, 2) One Black colour TVS XL 100 Motor Cycle having Reg. No JH09AT- 5067, 3) One Black colour Splendor plus Motor Cycle having Reg. No- WB56Q-3548, 4) One Black colour Bajaj CT-100 Motor Cycle having Reg. No-JH05E-950B, 5) One Black colour Hero Honda Splendor Motor Cycle having Reg. No-JH01AL-2163, 6) One Black colour Hero Splendor Plus Motor Cycle having Reg. No-JH24F-4786 and lodged this complaint against 1) Dulal Kumar (28 yrs) S/O Mahadeb Kumar @Manbhula of Vill+P.O- Kalma, PS- Jhalda, Dist- Purulia, 2) Nirmal Kumar (21 yrs) S/O Dinesh Kumar of Vill-Bara Honkol, PO-Oldih, PS- Kotshila, Dist- Purulia, 3) Salim Sk (23 yrs) S/O Sk, Mohammad of Bagandih, Ward No. 07, PS- Jhalda, Dist-Purulia, 4) Paran Mahato (19 yrs) S/O Sudhir Mahato of Vill-Bhurshu, PO-Koreng, PS-Baghmundi, Dist-Purulia, 5) Arun Mahato (41 yrs) S/O Haradhan Mahato of Vill-Urusaram, PO-Barorola, PS-Kotshila, Dist-Purulia, 6) Bidhan Ch. Mahato (31 yrs) S/O Abhinash Mahato of Vill-Baraganta, PS-Jhalda, Dist-Purulia to the effect that today (17/05/2021) myself along with C/571-Md. Hasib Khan, HG/1772-Fatik Ch. Kumar was engaged in Special mobile duty vide Jhalda PS GDE No- 544 Dtd 17/05/2021 and C.C. No- 1319/21 Dt- 17/05/2021. During Special Mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 11.45 Hrs. when myself with force was performing Naka checking in front of Jhalda New PS gate and Jhalda old PS gate above noted Motor cycles were detained as they were moving aimlessly and creating Halla. I apprehended riders of above noted motor cycles. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. So, It is known that there is every reason to believe that the riders of those Motorcycles came out from their home and moving aimlessly or making fun and they did not came for emergency purpose. Though National Directive for COVID-19 Management (Unlock-2) is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide order No- 79-CS/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 846-CS/2021 dtd. 24.04.2021 for restriction measure. And lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of West Bengal consolidated order No-647-ISS/2M-22/2020 dated-15/05/2021 for complete restriction measure.

As such the above persons violated the order vide order No- 79-CS/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 846-CS/2021 dtd. 24.04.2021 for restriction measure. And order No- No-647-ISS/2M-22/2020 dated-15/05/2021 which is extended till 30.05.2021. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycles with proper seizure list. I also arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.
