Sir,

I, PSI Habibur Rahman of Jhalda P.S. returned to PS with force and brought under seizure (i) One Hero Honda CD Delux M/C bearing Reg. No.- JH 09L 7163, (ii) One Hero Passion Pro M/C bearing Reg. No.- JH 01AW 7138, (iii) One Hero Super Splendor M/C bearing Reg. No.- WB 56K 8724, (iv) One Hero Super Splendor M/C bearing Reg. No.- JH 01CZ 0546 and lodged this complaint against 1. Banu Kumar (31) S/O Lt. Ijat Kumar of Vill- Birudih, PO-Jargo, PS-Jhalda, Dist-Purulia 2. Sk Kadir (19) S/O Sk. Chatubabu of Vill- Hussendih, PS-Jhalda, Dist-Purulia 3. Swapan Rajak (29) S/O Sankar Rajak of Vill- Ichag, PS-Jhalda, Dist-Purulia 4. Chinmoy Chandra (38) S/O Bhaktipada Chandra of Jhalda Dompura, Ward No-8, PS-Jhalda, Dist-Purulia 5. Sonulal Tudu (43) S/O Panru Tudu of Vill- Jaharhatu, PO-Begunkodar, PS-Kotshila, Dist-Purulia 6. Binod Mahato (33) S/O Rathu Mahato of Vill- Raghunathpur, PO-Begunkodar, PS-Kotshila, Dist-Purulia 7. Shibnath Mahato (18) S/O Lt. Ajit Mahato of Vill- Raghunathpur, PO-Begunkodar, PS-Kotshila, Dist-Purulia 8. Imran Kazi (19) S/O Babu Kazi of Vill- Kantadih, PS-Jhalda, Dist-Purulia to the effect that today (22/05/2021) myself along with C/386-Sibendhu Sinha, HG/1772-Fatik Ch. Kumar was engaged in Special mobile duty vide Jhalda PS GDE No- 736 Dtd 22/05/2021 and C.C. No- 1372/21 Dt- 22/05/2021. During Special Mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 18:35 Hrs. when myself with force was performing Naka checking in front of Jhalda old PS gate above noted Motor cycles were detained as they were moving aimlessly and creating Halla. I apprehended 04 (Four) Sl. No-1 to 4 riders of above noted motor cycles. I also detained 04 (Four) persons Sl. No.- 5 to 8 for not using mask and moving aimlessly. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. So, It is known that there is every reason to believe that the riders of those Motorcycles and 04 (Four) others came out from their home and moving aimlessly or making fun and they did not come for emergency purpose. Though National Directive for COVID-19 Management (Unlock-2) is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide order No- 79-CS/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 846-CS/2021 dtd. 24.04.2021 for restriction measure. And lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of West Bengal consolidated order No-647-ISS/2M-22/2020 dated-15/05/2021 for complete restriction measure.

As such the above persons violated the order vide order No- 79-CS/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 846-CS/2021 dtd. 24.04.2021 for restriction measure. And order No- No-647-ISS/2M-22/2020 dated-15/05/2021 which is extended till 30.05.2021. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycles with proper seizure list. I also arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodge against above noted 08 (eight) accd. persons as they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188 IPC and 51 (1)(b) of Disaster Management Act, 2005 and arrange for investigation.
