Sir,

In producing here with 03(Three) arrested accused persons namely (i) Rajib Mahato (27) S/O Naresh Mahato of Vill- Keruary, PS- Jhalda, Dist- Purulia (ii) Pana Nayak (25) S/O Mahesh Nayak of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia (iii) Panchanan Mahato (30) S/O Nityananda Mahato of Vill- Keruary, PS- Jhalda, Dist- Purulia and along with 03(three) seized Tractors- (i) WB55A 7866 (ii) WB55B 2493 (iii) WB55B 1258 all are attached with sand loaded trolleys. The fact in brief is that today (23.05.2021) during my Mobile duty at Jhalda Bus stand vide Jhalda P.S. GDE No- 766 Dated- 23/05/2021 & Jhalda PS CC No- 1377/21 Dated- 23/05/2021 at about 19:05 hrs. received a credible source information that few Tractors were carrying sand illegally and coming from Tribeni Ghat which is situated on Subarnarekha river at Jharkhand Purulia Border & going towards Kotshila side. To work out this information we went to Birsha more (On Purulia Ranchi Main road) and started Naka Checking. We intercept the said Tractors at Naka checking point at about 20:15 hrs and found the above noted tractors were tagged with trolley loaded with sand. On asked, the drivers disclosed their identity as mentioned earlier. On demand, they failed to produce any valid papers in respect of the Tractors which are attached with Trolley as well as loaded sand though sufficient time was given. During interrogation, the drivers of the said tractors confessed that they in connivance with the owner of said seized Tractors & others is doing this illegal business of sand and they have no proper paper or royalty challan. Then, I SI- Probodh Kr. Mahato arrested following accused drivers of said vehicles (as disclosed during interrogation)- (i) Rajib Mahato (27) S/O Naresh Mahato of Vill- Keruary, PS- Jhalda, Dist- Purulia (driver of the tractor WB55A 7866) (ii) Pana Nayak (25) S/O Mahesh Nayak of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia (driver of the tractor WB55B 2493) (iii) Panchanan Mahato (30) S/O Nityananda Mahato of Vill- Keruary, PS- Jhalda, Dist- Purulia (driver of the tractor WB55B 1258) under proper arrest memo and also seized the Tractors- (i) WB55A 7866, (ii) WB55B 2493 and (iii) WB55B 1258 with attached sand loaded Trolleys (approx 100 cft) in each Tractors.

It is also fact that though National Directive for COVID-19 Management (Unlock-2) is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide order No- 79-CS/2020 dtd. 12.04.2020 of the Government of West Bengal and Memo No- 846-CS/2021 dtd. 24.04.2021 for restriction measure. And lockdown is also going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of West Bengal consolidated order No-547-ISS/2M-22/2020 dated-15/05/2021 for complete restriction measure. Therefore, there is restriction of movement except emergency purpose. But during interrogation with the driver it is known that he has no come out for any emergency purpose. So he disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule.

On return to P.S., Put the arrested accused persons into the P.S. Lock UP after maintaining all formalities, kept the sand loaded seized Tractors at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Rajib Mahato (27) S/O Naresh Mahato of Vill- Keruary, PS- Jhalda, Dist- Purulia (ii) Pana Nayak (25) S/O Mahesh Nayak of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia (iii) Panchanan Mahato (30) S/O Nityananda Mahato of Vill- Keruary, PS- Jhalda, Dist- Purulia (iv) Owner of the Tractor having registration no WB55A 7866 (v) Owner of the Tractor having registration no WB55B 2493 (vi) Owner of the Tractor having registration no WB55B 1258 & others under proper section of law.
