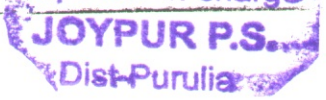

Sub: Prayer for lodging F.I.R. against arrested accused persons namely Madhusudan Mahato (26 yrs) S/o Mangal Mahato of Vill-Kulara PS-Joypur Dist-Purulia & 12 others.

Sir,

With due respect I SI Sudip Mahato of Joypur PS, beg to submit before you that on 18/05/2021 at about 09:25 hrs while myself along with force were performing Special Mobile duty at PS area and conducting raid against non-wearing of mask physical distancing maintaining at Arsha More Joypur Bazar on Purulia-Ranchi road as per order of my superior vide Govt. Memo No. 715-Home (Com)/RIM/ (Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distance norms should be strictly dealt with and Order No-647-ISS/2M-22/2020 Date-15/05/2021 & Memo No-629-ISS/2M-22/2020 dated 05-05-2021, Memo No-618-ISS/2M/2020 dated 30-04-2021 & Memo No-622-ISS/2M-22/2020 dated-01/05/2021 & Memo No. 486-CS/2021 dated 24.04.2021, Joypur PS GDE No-769 Date-18/05/2021 & CC No-1943/21 Date-18/05/2021 and found the following persons, were roaming at Arsha More Joypur Bazar on Purulia-Ranchi road SH-4A without any face cover / mask & were gather in a place without maintaining physical distancing. In spite of several request & reminder they refuse to wear mask and roaming at public place. To prevent the spread Covid-19 pandemic situation. I asked them to wear mask but they did not comply my request & roaming in the Joypur Bazar without face cover / mask. Myself along with accompanied force detained them at Hospital More they were coming from others villages. On being asked the following persons could not able to give any satisfactory answer for their presence at public place without face cover / mask. In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by Government order vide Memo No. 715-Home (Com)/RIM/ (Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distancing norms should be strictly dealt with and Order No-647-ISS/2M-22/2020 Date-15/05/2021 & Memo No-629-ISS/2M-22/2020 dated 05-05-2021, Memo No-618-ISS/2M/2020 dated 30-04-2021 & Memo No-622-ISS/2M-22/2020 dated-01/05/2021 & Memo No. 486-CS/2021 dated 24.04.2021. As such the following persons violated the order during this pandemic situation. Moreover the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons were arrested on 18/05/2021 from 09:45 hrs to 11:45 hrs, after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S.
