

In producing herewith, driver of tractor having Regd. number WB-81/0516, Sk. Bittu (25 Years) S/o- Sk. Ainul of Sir, Vill- Kashipur Sikaripara, PS- Kashipur, Dist- Purulia along with 02(Two) tractors i.e. (i) Mahindra B 275 DI (Red Colour) tractor having Regd. number WB-81/0516, Engine No RFNE02584, Chassis No RFNE 02584 along with trolley loaded with sand approx 75 - 80 Cft. (ii) Trak Star 536 (Blue Colour) tractor having Regd. number WB- 81/ 2512, Engine No NKD2DEJ0022, Chassis No M9KATABAAKVE01120 along with trolley loaded with sand approx 35-40 Cft and (iii) 2 pieces old Iron made "Belcha" having iron butt (iv) 02 pieces Iron made "Dhama" before you.

The nub of the fact in a nutshell is that today on 06.05.2021 at 09:45 hrs. I, PSI Gouranga Roy of Kashipur PS along with (i) C/74 Kamakshya Prasad Mandal and (ii) C/1256 Anadi Dhibar both of Kashipur PS, Dist-Purulia, left the PS for performing mobile duty under Kashipur P.S area vide Kashipur P.S GDE No 159 Dtd- 06.05.2021 and C.C No. 1026/21 Dtd. 06.05.2021. During my mobile duty, I received a tip off at 11:45 hrs. that some persons were loading some tractors with sand from the river bed of Darkeswar River near "Samsan Ghat" under Kolloli Mouza, Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolleys of said two tractors near "Samsan Ghat" under Kolloli Mouza, approx 100 miters from Beliadanga river bridge. Seeing the Police party, some persons leaving the tractors (loaded with sand in the attached trolleys) at Darkeswar River, tried to fled away from the spot, but after hot chased we are managed to apprehend one person. On being interrogation he disclosed his name and identity that Sk. Bittu (25 Years) S/o- Sk. Ainul of Vill- Kashipur Sikaripara, PS- Kashipur, Dist- Purulia and also stated that he is the driver of tractor No WB-81/0516. We rushed to the Tractor and detained the said tractors. We searched the said tractors and found that the trolleys are loaded with sand and also searched surrounding but could not trace out the rest persons & driver of another offending Tractor. Hence, I seized the above noted tractors along with trolleys loaded with sand approx 35-40 Cft and 75-80 Cft. and 02 pieces old Iron made "Belcha" having iron butt and 02 pieces Iron made "Dhama" and brought the said seized articles to Kashipur PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted seized tractors along with the trolleys for investigation.
