1. That the present complainant is a permanent resident of vill Sonaijuri under the jurisdiction of Kashipur P.S. and your complainant belongs to SURI caste.

2. That on 18-03-21 at about 9 A.M. the complainant went to Kashipur market (Kashipur Hat) with an intention to purchase Cow, from the said Hat (Market) and where two persons namely i) Soumya Mukherjee S/O Lt. Tarasankar Mukherjee ii) Anil Kr. Roy S/O Nagendranath Roy both are resident of vill: Dibakar bati, P.S. Indus Dist: Bankura (W.B) were also moving there.

3. That the said two persons without having any reason, abusing filthy language to the complainant and told him "SALA SURIGULA R PRACHUR PAISA HOYECHE TAI GORU KITE CHOLE ASECHE" and further stated that "TODER MOD BIKAI HOBE" NATUN KORE GORU KINE DUD PABSA HOBE NA" and due to this abusive as well as malign language the other person, who are also present in the said market, were laughing loudly as such the complainant feel very much humiliated and so the complainant raised objection against this inhuman behaviour of the accd. then the accd. persons being furious and restrained the complainant with an intention to physical assault and they were assaulted the complainant by their wearing shoes mercilessly and assaulted over the complainant's head and face and also stated to the complainant that "SURI JATTA CHIROKAL AMADER JUTAR TOLATE THAKBE" and subsequently after doing this inhuman brutal activities they are left the market and laughing loudly.

4. That local people of the market talk to each other that they were never seen any badly to be humiliated due to his caste. That the accd. persons intentionally humiliate your complainant, who is a member of schedule caste, in public place.

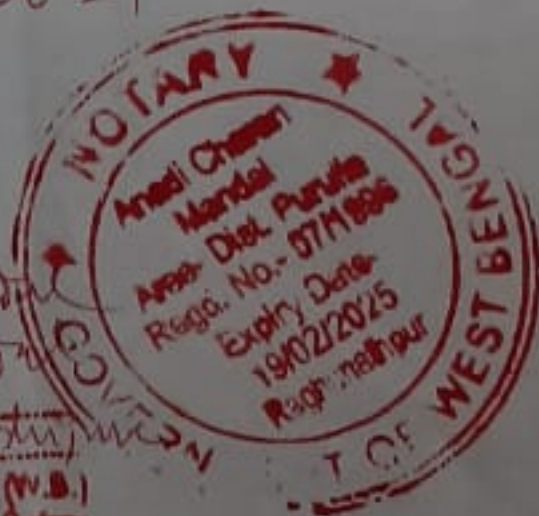
